

**MRPL Tender No 3410000010 for the Supply and Installation of Aviation Lamps for hazardous area application as per tender specification**

**योग्यतापूर्व मानदंड PQC (Pre-Qualification Criteria):**

- 1) The bidder should have executed at least one (1) completed order for Miscellaneous electrical works like earthing, cable laying, installation and maintenance of lighting etc. to any Hydrocarbon sectors like Refineries or Petrochemicals or Fertilizer plants or Oil & Gas Processing Plants of value not less than **Rs. 19.00 Lakhs** in the previous 5 years period ending last day of the month previous to the one in which this tender is floated. The bidder should submit copy of purchase order along with completion certificate or satisfactory performance certificate as documentary evidence supporting the execution of this order to be attached along with technical bid.
- 2) Bidder shall have a valid Class-A license issued by Govt. of Karnataka or shall possess equivalent electrical license of any other state in India for carrying out electrical works. Copy of valid license to be submitted. In case of a valid equivalent electrical license holder of any other state in India, the bidder shall submit an undertaking to take Class- A License issued by Govt. of Karnataka within 4 months of placing the order.
- 3) Bidders who have been issued orders for similar works in MRPL and executed the same during last 3 years period ending last day of the month previous to the one in which bids are invited shall provide satisfactory performance certificate or completion certificate from MRPL.
- 4) The bidder should not be under blacklist or holiday list of MRPL or Ministry of Petroleum & Natural Gas (MoPNG) or not debarred by orders issued by DoE. The bidder should submit an undertaking to this effect along with the technical bid.

**Note:**

- a. In line with the Government policy, qualified Micro and Small Scale Enterprises (MSEs) will be given relaxation up to 15% on prior experience (for sl.no. 1). i.e **16.15 Lakhs**.
- b. Startups are exempted from prior experience for this tender.
- c. PQC value is exclusive of Taxes.

d. For MSE- Purchase Preference (PP), Bidder shall be Manufacturer for supply items. As per the MoMSME, the benefits of the Purchase Preference (PP) extended only to manufacturers registered under this and are not applicable to traders or dealers or resellers or distributors or authorized agents etc. Accordingly, the eligible MSE bidders shall be registered for the item tendered. The Bidder shall submit proof that he is a manufacturer of the item for which he is quoting and he shall highlight the details of his manufacturing status in the MSE certificate against the item he is proposing to bid in the tender.

**बीईसी or BEC (बोली मूल्यांकन मानदंड or Bid Evaluation Criteria):**

1. The bidder shall comply with all the technical specification and scope given in the tender.
2. The bidder from a country which shares the land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority (i.e. Registration Committee constituted by Department for Promotion of Industry and Internal Trade (DPIIT)). The bidder should submit an undertaking to this effect along with the technical bid."
3. The bidder should quote for all items and offer for partial items will not be considered for techno-commercial evaluation. A confirmation to this effect shall be attached with technical bid.
4. Techno-Commercially accepted bids will be evaluated on Overall L1 basis, i.e. lowest landed cost to MRPL. Quantity wise can't be split.

**5. रद्द करने संबंधी मानदंड or Rejection Criteria:**

**The bids are liable for rejection in following cases:**

- a. Bids received after the due date and time of bid submission shall be summarily rejected.
- b. Bids received without EMD or with Insufficient EMD as on the bid closing date and time shall be summarily rejected. However, Micro and Small Enterprises (MSEs) registered with NSIC or Udyam or any other body specified by Ministry of Micro, Small & Medium Enterprises (MoMSME) or Start-up companies recognized by DIPP or

PSUs or Categories as prescribed in GeM GTC are exempted from submission of EMD (as applicable). Such bidder needs to submit relevant and valid documents along with technical bid of tender.

- c.** Offer sent without having the prescribed bidding document of MRPL, non-adherence to technical or commercial terms & conditions, GeM Terms & Conditions, Unpriced bid and Price bid not in the prescribed format, incomplete bids and bids with deviations to the tendered scope of work shall be liable for rejection.
- d.** Non-compliance to any of PQC or BEC will be liable for rejection.
- e.** If technical bid & price bid are submitted together.
- f.** Bids found to have been submitted with falsified or incorrect information.
- g.** If Bidder is in Holiday list or Blacklist of MRPL or Ministry of Petroleum & Natural Gas (MoPNG) or debarred orders issued by DoE.
- h.** Consortium Bids shall not be accepted.
- i.** Offer submitted in any currency other than INR shall be rejected.
- j.** Any false declaration and non-compliance of Restrictions on procurement from the bidder of a country which shares a land border with India.
