

MRPL Tender No 3700004916 for the Procurement of Proximity Barriers and Safety SOV Monitoring Relays In Phase-2 Units of Refinery as per tender Specification

योग्यतापूर्व मानदंड PQC (Pre-Qualification Criteria):

- 1) The bidder shall be a manufacturer or authorized agent (authorized dealer or channel partner of the manufacturer) of **Proximity barriers and Safety SOV monitoring relays**. If the bidder is not a manufacturer he shall submit valid authorization certificate duly issued by the manufacturer which should also contain undertaking of the manufacturer to provide necessary warranty cover as per bid requirements. Documentary proof should be submitted along with technical bid.
- 2) The bidder should have executed at least 1 (one) completed order for the Supply of **Safety SOV Relays** meeting tender specification to any hydrocarbon sectors like refineries or petrochemicals or fertilizers plants or oil & gas processing plants of value not less than **Rs. 15.00 Lakhs** in the previous 5 years period ending last day of the month previous to the one in which this tender is floated. The bidder should submit copy of purchase order along with Invoice copy as documentary evidence supporting the execution of this order to be attached along with technical bid.
- 3) The bidder should have executed at least 1 (one) completed order for the Supply of **Proximity barriers** meeting tender specification to any hydrocarbon sectors like refineries or petrochemicals or fertilizers plants or oil & gas processing plants of value not less than **Rs. 8.00 Lakhs** in the previous 5 years period ending last day of the month previous to the one in which this tender is floated. The bidder should submit copy of purchase order along with Invoice copy as documentary evidence supporting the execution of this order to be attached along with technical bid.
- 4) The bidder should not be under blacklist or holiday list of MRPL or Ministry of Petroleum & Natural Gas (MoPNG) or not debarred by orders issued by DoE. The bidder should submit an undertaking to this effect along with the technical bid.

Note:

- a. In line with the Government policy, qualified Micro and Small Scale Enterprises (MSEs) will be given relaxation up to 15% on prior experience (for sl.no. 2 & 3 above). i.e **12.75 Lakhs & 6.80 Lakhs**
- b. No relaxation in the prior experience for Startups for this tender due to public safety, health, critical safety, operations & equipment's etc.
- c. PQC value is exclusive of Taxes.
- d. For MSE- Purchase Preference (PP), Bidder shall be Manufacturer for supply items. As per the MoMSME, the benefits of the Purchase Preference (PP) extended only to manufacturers registered under this and are not applicable to traders or dealers or resellers or distributors or authorized agents etc. Accordingly, the eligible MSE bidders shall be registered for the item tendered. The Bidder shall submit proof that he is a manufacturer of the item for which he is quoting and he shall highlight the details of his manufacturing status in the MSE certificate against the item he is proposing to bid in the tender.

बीईसी BEC (बोली मूल्यांकन मानदंड Bid Evaluation Criteria):

1. The bidder shall comply with all the technical specification and scope given in the tender.
2. The manufacturer shall certify that the item or equipment offered would not be in "End of Support" for a minimum of 10 years from the date of end of warranty period as specified in the tender. In case the bidder is other than manufacturer, above declaration from the manufacturer shall be submitted by the bidder.
3. The bidder from a country which shares the land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority (i.e. Registration Committee constituted by Department for Promotion of Industry and Internal Trade (DPIIT)). The bidder should submit an undertaking to this effect along with the technical bid."

4. Techno-Commercially accepted bids will be evaluated on item wise L1 basis, Quantity cannot be split.
5. **रद्द करने संबंधी मानदंड Rejection Criteria:**

The bids are liable for rejection in following cases:

- a. Bids received after the due date and time of bid submission shall be summarily rejected.
- b. Bids received without EMD or with Insufficient EMD as on the bid closing date and time shall be summarily rejected. However, Micro and Small Enterprises (MSEs) registered with NSIC or Udyam or any other body specified by Ministry of Micro, Small & Medium Enterprises (MoMSME) or Start-up companies recognized by DIPP or PSUs or Categories as prescribed in GeM GTC are exempted from submission of EMD (as applicable). Such bidder needs to submit relevant and valid documents along with technical bid of tender.
- c. Offer sent without having the prescribed bidding document of MRPL, non-adherence to technical or commercial terms & conditions, GeM Terms & Conditions, Unpriced bid and Price bid not in the prescribed format, incomplete bids and bids with deviations to the tendered scope of work shall be liable for rejection.
- d. Non-compliance to any of PQC or BEC will be liable for rejection.
- e. If technical bid & price bid are submitted together.
- f. Bids found to have been submitted with falsified or incorrect information.
- g. If Bidder is in Holiday list or Blacklist of MRPL or Ministry of Petroleum & Natural Gas (MoPNG) or debarred orders issued by DoE.
- h. Consortium Bids shall not be accepted.
- i. Offer submitted in any currency other than INR shall be rejected.
- j. Any false declaration and non-compliance of Restrictions on procurement from the bidder of a country which shares a land border with India.
