2.0 Brief Scope of Work

Definition: - 'Client'- Mission Directorate National Health Mission, Department of Health & Family Welfare, Govt. Of Odisha

NHM has entrusted the renovation and construction of various Block level Primary Health Centers (PHCs), Community Health Centers (CHCs), BPHUs, IPHLs, CCB Buildings, CSSD, ETP etc. in different districts of Odisha, in accordance with the Indian Public Health Standards, to a suitable and qualified construction agency. The Public Sector Unit (Govt. of India Enterprises) Engineering Projects (India) Ltd is hereby engaged by NHM, Odisha as its Project Management & Executing Agency for executing the renovation and construction of various Block level Primary Health Centers (PHCs) and Community Health Centers (CHCs), BPHUs, CCBs, IPHLs, MCH Buildings, CSSD, ETP etc. identified by NHM, Odisha in different districts of Odisha ("Health Institutions"), in accordance with the Indian Public Health Standards (hereinafter referred to as the "Project").

Scope of work covers but not limited to Concept to Commissioning, Engineering Consultancy for Planning, Architectural and Structural design and drawing for the total building including Internal & External electrical works, Substation, DG sets, Fire Fighting, Sanitary and Plumbing works, Drainage & Sewerage works, Compound wall, Air Conditioning, Audio Visual System, Acoustic and interior furnishing, lifts, Solar PV etc. including vetting of drawings, all approval/clearances from local, state bodies as may be required including all the periodical site visits to site by Consultant/design team as required as per scope of work (Excluding Soil Investigation).

For CCB and CHC in all districts EPIL has prepared primary drawing for plan, structure, MEP, Fire Fighting, DPR, preliminary estimate which are not included in the scope of consultant. The consultant has to do balance work for CCB and CHC.

Apart from above, any other services not covered above but required as per direction of EPI and as per detailed scope of work is included in the draft agreement along with NIT.

Assistance in preparation of tender documents (if required) generally as per prevailing CPWD/OPWD/CVC, drawings, specifications, bill of quantities and other bid documents required to undertake construction of project. Submission of bid documents to 'Client' and taking approvals.

Modify Design and drawings if so decided by 'Client' or EPIL and submit the same for formal Approval of the 'Client'. Approval and Modifications/Revisions/Improvements, Changes in Design and Drawings during site execution requirement, as per 'Client', EPIL, PWD requirement has to be taken by Consultant.

All formalities and clearances with necessary set of designs & drawings for handling over of the project, SOP for running and maintenance of different facilities and equipment, preparation of AMC documents, detailed measurements of civil and MEP Provisions for maintenance of the building (post construction). Relevant site visits during defect liability period.

4.0 Minimum Pre-Qualification/ Eligibility Criteria: -

Method of Evaluation- Quality cum Cost Based Selection (QCBS) Criteria:

The duly constituted Tender Evaluation Committee shall evaluate the Technical Proposals on the basis of their responsiveness to the Terms of Reference and by applying the evaluation criteria, **Quality and Cost Based Selection (QCBS)** specified hereunder. In the first stage of evaluation, a proposal shall be rejected if it is found deficient as per the requirement indicated in the NIT for responsiveness of the proposal. Only responsive proposals shall be further taken up for evaluation. Evaluation of technical proposal will start first and at this stage the financial bid (proposal) will remain unopened. The proposals will be evaluated, based on the eligibility criteria and submission of all the requisite information/documents as asked hereunder.

(a) The Architect and Design Consultant firm should have experience of successfully completed assignment of Comprehensive Architectural and Engineering Consultancy services from concept to commissioning of similar work during the last 7 (seven) years ending last day of month previous to the one in which applications are invited should be either of the following:

Three similar works, each costing not less than the amount equal to **FORTY PERCENT (40%)** of estimated cost of project for which service to be provided.

OR

Two similar works, each costing not less than the amount equal to **FIFTY PERCENT (50%)** of estimated cost of project for which service to be provided.

OR

One similar work of aggregate cost not less than the amount equal to **EIGHTY PERCENT (80%)** of estimated cost of project for which service to be provided.

"Similar work" shall mean Consultancy Services including Architectural & Structural, M.E.P Services and Development of hospital building.

Note- Bidder shall submit copies of Completion certificates along with LOA / LOI, Contract agreement clearly mentioning the detail scope of work, value of work, date of start, time as per LOI and actual date of completion and actual value of work completed. The experience certificate in this regard should be issued by officer not below the rank of Executive Engineer / Project Manager / Unit Officer. In case the verification of certificate will not be received within the stipulated time

given by EPIL then the same will not be considered for evaluation of bidder.

- (i) For evaluation purpose, the completion cost of works mentioned in the Completion Certificate shall be enhanced by Seven Percent (7%) per annum till the end of month prior to date of NIT.
- (ii) The experience certificates issued by any Government Organizations / Semi Government Organizations / Autonomous Bodies / Municipal Bodies / Central and State PSUs shall be accepted for assessing the eligibility of the tenderer. However, the completion certificates issued must be supported by work order/Agreement & completion certificates
- (iii) The Joint Ventures/ Consortium are not accepted.
- b) Should have average annual financial turnover on consultancy services amounting at least 50% of the estimated consultancy fee put to tender (Rs. 7.40 Lakhs) during the last three consecutive financial years ending on 31.03.2023. Turnover certificate with balance sheets duly certified by a Chartered Accountant along with UDIN issued by ICAI is also to be submitted.
- c) Should not have incurred any losses in more than two years during the immediate last five consecutive financial years, ending 31.03.2023, Copies of Annual report/balance sheet and a No loss Certificate duly certified by a Chartered Accountant along with UDIN issued by ICAI is also to be submitted.
- d) One of the Director/Partner/Proprietor of company should be registered with 'Council of Architecture' & should have minimum ten years of experience in the field of Architectural & Engineering Consultancy work or Bidder can associate with an Architect who should be registered with 'Council of Architecture' & should have minimum ten years of experience in the field of Architectural & Engineering Consultancy work.
- e) Bidder shall furnish details of Skilled and Trained Manpower Including Architect, Engineers, and Technical staff employed and detail of software and hardware etc. available with the consultant.
- f) Bidder having office in Odisha state with Copy of proof of Office Address. (Rent agreement or any other supporting document)
- g) Bidder has to submit undertaking regarding details of Constitution of firm/Company along with the details of its Directors as per enclosed Annexure-C. In case the bidder fails to submit Constitution of firms with the bid along with the details of its firm Directors as per Annexure-C their bid will be rejected.
- h) The Bidder should not be currently declared ineligible / suspended / blacklisted / banned / debarred by EPIL or by any Central/State Govt. Department/Public Undertaking or Enterprise of Central/State Government and such ban should not be in force at the time of submission of the bid or extended deadline for submission of bid. Bidder has to submit a notarized self-declaration with the bid in respect of the same that "(......Agency Name...) has not been currently declared ineligible / suspended / blacklisted / banned / debarred by EPIL or by any Central/State Govt. Department/Public Undertaking or Enterprise of Central/State Government and such ban should not be in force at the time of submission of the bid or extended deadline for submission of bid".

- i) The Associate Consultant will have to make available 02 personnel (One Architect and One Civil Engineer) at Bhubaneswar for day to day coordination with the Client and EPI. The rate of recovery in case of Non-compliance will be as follows:
 - 1. Architect with 10 years of experience Rs. 50,000/- per month
 - 2. Civil Engineer with 10 years of experience Rs. 50,000/- per month

The compliance period will be applicable for entire project duration (24 months as per agreement with Client) including extended time w.e.f 22.10.2022. The Associate consultant shall make his own arrangements to accommodate the above deputed staff at Bhubaneswar.

Notwithstanding anything stated in tender, EPI reserves the right to assess the capabilities and capacity of the tenderer to perform the contract, in the overall interest of EPI. In case, tenderer's capabilities and capacities are not found satisfactory, EPI reserves the right to reject the tender. The credentials of the Bidders with respect to Technical & Financial criteria shall be verified and inspection of the works, if required, to be carried out by EPI. If not found satisfactory by EPI, their bid will be considered non-responsive and rejected.

The credentials of the Bidders with respect to Technical & Financial criteria shall be verified and inspection of the works, if required, to be carried out by EPI. If not found satisfactory by EPI, their bid will be considered non-responsive and rejected.

5.3 Part 3- Presentation by the selected bidder (Max Marks=30)

The bidders scoring minimum 55 marks in above Part 1 and 2 shall be invited to make presentation to Committee Constituted by EPI to demonstrate their technical and financial capabilities. The maximum score for making the presentation is 30 marks. The score will be provided based on bidders potential to execute design and engineering for Public Buildings based on depth of their experience, expertise of technical manpower to adopt new and emerging technologies etc as listed below:

Note: A Minimum 15 marks are to be secured by bidder in Part 3– Presentation.

The presentation will be at EPIL, Bhubaneswar. The time and venue for presentation will be intimated separately.

Short listing of technically qualified bidder will be based on the minimum 70 marks in aggregate obtained in Part1, Part2 & Part3. However, EPI reserves the right to select any one bidder or multiple bidders for association depending upon their credentials/competencies/project requirements/prevailing market condition, etc. at its sole discretion without assigning any reason.

5.4 Opening and Evaluation of Financial Bid

The Financial bids of "Technically qualified" bidders shall be opened. The Proposal with lowest Consultancy fee will be given a Financial Score of 100 and other financial Proposals will be given financial scores which is ratio of lowest offer to their offered Consultancy fee multiplied by 100.

On the basis of the combined score for Technical Score and Financial Score with weightage of 70:30, the bidders shall be ranked in terms of the total score obtained. The proposal obtaining the highest total combined score will be ranked as H1 followed by the proposals securing lesser scores as H2,H3 etc. Bidder with H1 score shall be recommended for award of contract. The bidder quoting lowest Consultancy fee in Financial Bid may or may not be score H1.

There will be no negotiation with selected bidder except under circumstances as per current CVC circulars.

The Applicant who has quoted the lowest price will be given a score of 100. The Applicants will be allotted score relative to the score of Applicant with lowest quote, which will be as below:

 $Fs = 100 \times FL/F$

Where:

Fs = The financial score of the Financial Proposal being evaluated

FL = The price of lowest priced Financial Proposal

F = The price of Financial Proposal under consideration

The score of technical proposals would be given 70% weightage and that of the financial proposals would be given 30% weightage. The weighted total score of both the Technical and Financial proposals shall be used to rank the Applicants. Work will be awarded to a bidder who is ranked highest in total score.

The first ranked Applicant is eligible for award of the work.

Total Score = $70\% \times Ts + 30\% \times Fs$

For Example:

Let's say there are 3 pre-qualified bidders: A, B & C

Technical Score of bidders after evaluation of technical criteria:

A = 70, B= 80 & C= 90

Say the % Consultancy Services Fee in the financial proposals of bidders are as under: A= 7, B= 5 & C= 6

The financial score is given as per the formula: (Lowest % Consultancy Services Fee against the % Consultancy Services Fee of the bidder) X 100

Financial Score of A= (5/7) X 100 = 71.4 % of marks 20

Financial Score of B= (5/5) X 100 = 100 % of marks 20

Financial Score of C= (5/6) X 100 = 83.3 % of marks 20

Final Combined Technical and Financial Score of the bidders is as per the formula:

(Technical Score X 0.70)+ (Financial Score X 0.30)

Bidder A= (70 X 0.70) + (71.4% X 30) = 70.42 -- H3

Bidder B= (80 X 0.70) + (100% X 30) = 86.00 --- H2

Bidder C= (90 X 0.70) + (83.3% X 30) = 87.99 --- H1

Hence Bidder C, with highest combined score shall be recommended for award.

5.5 Evaluation of the consultants shall be subject to through verification of their documents related with credentials and BG and inspection of similar consultancy works carried out / in progress by them, through a Technical Scrutiny Committee of experts to be constituted by EPIL. Price bids of all eligible bidders will be opened only after receiving the confirmations of Credentials & BG from the concerned Department/Bank.

Even though a bidder may satisfy the above requirements, he would be liable to disqualification & not considered for the opening of Price bid if:

- a) Not submitted Tender Fee/EMD as per NIT condition.
- b) Misrepresentation in the forms, statements and attachments submitted in the pre qualification document are proved to be incorrect, false and misleading.
- c) EPI reserves its right to take appropriate action including disqualification of tenderer(s) as may be deemed fit and proper by EPI at any time without giving any notice to the Bidder in this regard. The decision of EPI in the matter of disqualification shall be final and binding on the Bidders.
- d) EPI reserves its right to take appropriate action including disqualification of tenderer(s) as may be deemed fit and proper by EPI at any time without giving any notice to the Bidder in this regard. The decision of EPI in the matter of disqualification shall be final and binding on the Bidders
- e) Currently (till the last date of bid submission of the tender or till the last date of extended tender) they have record of poor performance such as abandoning the work, rescinding of contract for which the reasons are attributable to the non-performance of the contract, inordinate delay in completion, consistent history of litigation / arbitration awarded against the contractor or any of its constituents or financial failures due to bankruptcy etc. in their on-going / past projects.
- f) If bidder have submitted incompletely filled in formats without attaching certified supporting documents and credentials to establish their eligibility to participate in the Tender.
- g) If documents are not uploaded by the bidder as per instructions/due to special characters while saving files the files are unable to download the bids will be disqualified.

- h) In case of existing contractors of EPI, if progress is not satisfactory in any of the project their bid will be rejected.
- i) The credentials of the Bidders with respect to Technical & Financial criteria shall be verified and inspection of the works, if required, to be carried out by EPI. If not found satisfactory by EPI, their bid will be considered non-responsive and rejected.
- i) If the tenderers attempt to influence any member of the committee. EPI reserves its right to take appropriate action including disqualification of tenderer(s) as may be deemed fit and proper by EPI at any time without giving any notice to the contractor in this regard. The decision of EPI in the matter of disqualification shall be final and binding on the tenderers.
- k) The Bidder /MOU partner have been blacklisted in any State Govt./Municipal Corporations/Central Govt./any State Govt. Organizations, Urban Local Body and/or its Undertaking company or its SPV, Asian Development Bank/World Bank or similar international funding agencies/ organizations during last ten years ending last day of the previous month of date of NIT.
- The Bidder is expected to examine all instructions, forms, terms and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or submission of a bid not substantially responsive to the bidding documents in every respect will be at the bidder's risk and may result in the rejection of its bid.
- m) In case, any documents, information and/or certificate submitted by tenderer is found to be incorrect/false/fabricated or the tenderer has breached the terms and condition of integrity pact, EPI at its discretion may disqualify/reject/terminate the tenderer, forfeit the EMD and the tenderer shall also be liable to be suspended/debarred for a period which shall not be less than one year extending till maximum for a period of 3 years.

Note: If any tenderer withdraws his tender before the said period or issue of letter of acceptance/intent, whichever is earlier, or makes any modifications in the terms and conditions of the downloaded tender which are not acceptable to the EPIL, then the EPIL shall, without prejudice to any other right or remedy, be at liberty to forfeit entire amount of Earnest Money as aforesaid.

- **7.0** An attested copy of power of attorney/affidavit/Board. Resolution executed as under shall accompany the 'Tender Documents'.
 - a) In case of Sole Proprietorship, an affidavit of Sole Proprietorship and if the tender is signed by any other person Power of Attorney by the Sole Proprietor in favour of signatory.
 - b) In case of Partnership, if document is not signed by all the partners, Power of Attorney in favour of the Partner/person signing the documents authorizing him to sign the documents. The person signing the documents should also have a specific authority to refer disputes with the partnership firm to arbitration.
 - c) In case of Company, copy of the Board Resolution authorizing the signatory to sign on behalf of the Company.

The tenderer shall furnish the name (s) and designation of relative (s) if any, employed by EPI.

- **8.0** For proper uploading of the bids on the portal namely CPP Portal: https://gem.gov.in/ (hereinafter referred to as the 'portal'), it shall be the sole responsibility of the bidders to apprise themselves adequately regarding all the relevant procedures and provisions as detailed at the portal, as and when required. The EPI in no case shall be responsible for any issues related to timely or properly uploading/ submission of the bid in accordance with the relevant provisions of Section Instruction to Bidders of the Bidding Documents.
- 9.0 Bidders including MSME bidders can download the bid document from the portal without registering or paying document fees; however, interested bidders have to pay tender fees for participating in the tendering and submitting the bid.
