Accordingly following provision will be added in SCC/schedule of items for information of bidders "This is a proprietary tender and only the NALCO approved vendors can participate in this tender. The bidders to whom bid invitation has been sent through "Invite Bidder" option in the GeM portal can participate in this tender. The offers of any other bidders (to whom invitation to participate in the bid has not been sent through GeM portal) will be treated as unsolicited and will be summarily rejected"

- L. In GeM Custom Bidding, there is no provision of quoting rates against individual items of schedule of items, the bidder can quote only lumpsum price (incl. GST) for the tender. Since there is only one item, hence Quantity will be mentioned in the tender and bidder will be asked to quote lumpsum price for three years, unit rate will be derived by Nalco by dividing lumpsum rate with qty. L-1 bid as evaluated on GeM will be based on lumpsum quoted amount incl GST.
