6	Manufactures/Bidders ISO 9001:2015, ISO 14001:2015,ISO 45001:2018 , ISO 3834-1:2021 certificate/CE certificate/GMP certificate approved by Govt. of India. Valid Authorisation letter must be submitted by the Bidder .
7	Manufacturer ITR audit report/balancesheet for assessment year – 2021-2022/2022-2023/2023-24.
