**LOCAL PURCHASE (LP) SANCTION OF PERISHABLE ITEMS (FRUITS FRESH) FOR  
THE PD FROM 01 OCT 2024 TO TILL CONCLUSION OF REGULAR CONTRACT**

1. Ref the fwg :-
  - (a) IHQ of MoD (Army) letter No 63060/Q/ST-5 dt 29 Sep 2009, copy fwd vide this HQ letter No 303041/R/ST-5 dt 07 May 2010.
  - (b) HQ DB Area (ST) letter No 70101/Oct 24-25/ST-5 dt 29 May 2024.
  - (c) HQ MG & G Area (ST) letter No 1009/AR/Oct 24-25/ST-5 dt 18 May 2024.
2. It is intimated that the subject contract in r/o Bangalore and Kirkee stns are under re-tender. The contracts are likely to be concluded in near future. However, in the meantime LP sanction is hereby accorded for the pd from 01 Oct 2024 to till conclusion of regular contract to meet the reqmt of tps.
3. LP to be carried out at most economical and competitive rates **on as required basis**. Respective IFAs should be kept info and advice/concurrence, where applicable should be obtained. Brigs ASC are requested to monitor LP rates to safeguard interest of State and tps. Brigs ASC/Comdts/OsC Sup Dep to personally brief respective Fmn/Stn Gdrs on the modalities of LP due to non conclusion of contracts.
4. In addn to the above, Brigs ASC are also requested to ensure the fwg :-
  - (a) Local procurement of perishable items (Fruits Fresh) should be done under the applicable CFA as per DFPDS-2021.
  - (b) Till conclusion of regular contract, LP should be at reasonable rates comparable to ECR.
  - (c) CCR/LTR/ECR/LP rates (as applicable) of neighbouring stns should also be considered while determining LP rates.
  - (d) DFS-2021, Specification No 359 (Revised) for Fruits Fresh.

6. The fwg actions to be ensured after completion of LP :-

(a) LP rates to be intimated within 24 hrs of purchase made as per format given below:-
