- 1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.
- OM_No.1_4_2021_PPD_dated_18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
- 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid

for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

- 3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
 - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
 - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

- 1. The bidder shall himself be an OEM of Electromagnets or the party shall enclose authorization from OEM for submission of quotation. The authorization should be obtained clearly mentioning the GEM bid number.
- 2. The OEM or its authorised dealer should have supplied Electromagnets/Coils/Circular magnets to any Ce ntral / State Govt Organization/ PSU / Public Limited Company in last 5 years before the bid opening date. Copies of relevant orders to be submitted along with bid in support of having supplied at least 1 Electroma gnet/Coil/Circular magnet for scrap handling of at least 5 KW during any of the year.

COMMERCIAL TERMS AND CONDITIONS:

- 1) Authorized and competent person of the firm should put their seal and signature on format for Annexur e-I, NON-CO LLUSIVE TENDERING CERTIFICATE, APPENDIX-III & FILLED ATTACHED COMMERCIAL DATA SHE ET. Self-certified document for MAKE IN INDIA component is to be submitted with the bid.
- 2) The tax invoice (s) should mandatorily contain the GSTIN of the consignee and RSP back up PO Number f or reference.
- 3) Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only. (RSP GSTIN No:21AAACS7062F2ZP)
- 4) No technical deviation is acceptable. The firms should submit proper data she et of the item offered aga inst this bid.

- 6) The firms participating against this bid shall be deemed to accept all terms & 5 / 8 conditions of the bid.
- 7) The Local Content Confirmation (in %) should be from OEM.
- 8) RPN clause: Subject to the terms and conditions of the GeM contract, if the Supplier neglects or fails to p erform the contract by the time or times agreed up on, for any reason other than Force Majeure, the PURC HASER after having co me to know of such negligence or non-performance, after giving 14 to 30 days' noti ce to the SELLER to rectify or such any extended period that the SELLER and PURCHASER may action for s upply of similar materials, mitigating any loss es, at the risk and cost of the Supplier as far as the undeliver ed quantity in that Delivery Period is concerned. The Right of the Purchaser for Risk Purchase Action is in a ddition to the Right of Purchaser to terminate the Contract due to the fault of the Supplier. The price differential in case of higher cost to RSP S AlL, if any, shall have to be borne by the defaulting supplier. RS P reserves the right to recover the price differential from pending bills of the supplier in other SAIL units. M oreover, the defaulting supplier shall have no claim over the quantity, which they failed to supply.
- 9) RSP shall be placing Back-Up order against GeM contracts on Successful Bidder(s). The concerned bidde r has to mention the Back-up order number in the invoices for proper accounting of material upon receipt in RSP.
- 10) Hard Copy of the Invoice signed and with Seal (or Digitally Signed Invoice), h as to be sent to DGM (F& A), Store Bills, Administration Building, Rourkela Steel Plant, Rourkela, Odisha 769011. This will help us in ensuring timely payment s.
- 11) SAIL-RSP is entitled to claim credit of input tax paid on the supply of the bid item (as applicable).
- 12) In case any of the above GTC, STC & ATC terms are not acceptable to the bid der, the bidder may kindly refrain from participating in the bid.
- 13) Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in t he Bid document, ATC and Corrigendum if any
- 14) In case any specific adverse report is received against a tenderer, as an information or upon enquiry m ade by SAIL, in respect of capabilities and performance of the tenderer, after receipt of tender but before t he opening of the Price Bids, the quotation / tender submitted by such tenderer is liable to be rejected on t he basis of recorded reasons and with the approval of the Next Higher Authority /Chief Executive Officer of the Plants/ Chief Executive of the Units. If such report is received after opening of the price bids, then also the quotation / tender of that tenderer is liable to be rejected after recording the reasons and with the approval of the Next Higher Authority / Chief Executive Officer of the Plants/ Chief Executive of the Units"
- 15) Bidders must note that in case of submission of offer, it will be assumed that you have accepted and w ill abide by the following clause: -
