#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

a. Copy of PAN Card.

- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

#### 3. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

#### 4. Buyer Added Bid Specific ATC

- 1. Inspection clause: PDI TO BE DONE BY NTPC/NSPCL REPRESENTATIVE AT VENDOR'S WORK AS PER APPR OVED QAP.
- 2. Guarantee/ warranty Clause: All items should be guaranteed against poor workmanship/ manufacturing defect for a period of 18/12 months from the date of supply/commissioning of material, whichever is earlier

- 7. Drawing and QP Approval: Party has to submit Quality Plan in line with NSPCL's Reference QAP for approval from NSPCL within 15 days of issue of PO.
- 8. Payment Terms:
- a. 95% payment within 10 days after receipt & acceptance of material at site.
- b. Balance 5% on submission of PBG @ 5% of PO value.
- 9. Delivery period and Schedule: Delivery to be completed preferably within 06 months from receipt of PO. However, the vendor must endeavour to supply material at the earliest.
- 10. Bid Evaluation Criteria: Bid Evaluation shall be done Item wise.
- 11. Special Instructions:
- a) Items to quoted strictly, as per Item long text.

#### **Bidders Participation Criteria**

NSPCL, a joint venture of NTPC Ltd. and Steel Authority of India Ltd. referred to herein as 'the Employer', i ntends to engage an agency for supply of Goods and related Services as per specifications, Scope of Work as detailed in the Bidding documents.

The items being procured in this BID are spares for the existing equipment installed by M/s GE POWER IND IA LIMITED. in the Employer Plants. Hence, the BID submitted by the OEM- M/s GE POWER INDIA LIMITED. (GEPIL) or channel partner of M/s. GEPIL will be accepted. BIDs from any other vendors will no be considered for evaluation.

In case of Dealer/Channel partner participating in the bid, Bid Specific authorization letter is to be submitte d with the bid.

The Employer reserves the right to accept or reject any Bid, and to annul the bidding process and reject all Bids at any time prior to Contract award, without thereby incurring any liability to the affected Bidder(s) or any obligation to inform the affected Bidder(s) of the grounds for the Employer's action.

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
