- 1. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 5. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. - 6. ADDITIONAL TERMS & CONDITIONS

- 1. **Payment :** Payment will be made on monthly basis, after monthly complet ion of Service & Service Acceptance by the Consignee Officer, Geophysics Divisi on, GSI, SR, Hyderabad.
- 2. **Price:** The Price quoted should include all taxes, etc. No other payments will be made except the quoted price.
- 3. **Earnest Money Deposit (EMD):** EMD of *Rs. 76,500/- (Rupees Seventy Six Thousand Five Hundred Only)* has to be submitted in the form of FDR or Bank Guarantee or Insurance Surety Bonds in favor of The Additional Director G eneral, GSI, SR, Hyderabad and should reach this office within One Week from t he date of Opening of the Bid, failing which the Bid will be liable for rejection. Fo r availing EMD Exemption the firms has to be submit relevant documents in claim of their exemption as per Rule 170 (i) of GFR 2017.
- 4. **Performance Security:** Successful bidder has to submit Performance Security @ 5% of the Contract Value in the Form of FDR or Bank Guarantee or Insurance Surety Bonds in favor of The Additional Director General, GSI, SR, Hyderabad, valid for a period of 8 Months.
- 5. The Bidder should sign/stamp on the SOW (Scope of Work) sheet of the GEM Bid document and upload the same along with their technical bid documents fo r consideration of their bid technically.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
