1. 4. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

Eligibility of Bidders will be examined as per ATC.

1. BID ESTIMATE VALUE: Rs. 2419032.00

02. BIDDER TURNOVER: OEM and authorized dealer are allowed to participate in the Bid. Certificate of Financial turnover: at the time of submission of Bid, Bidder has to submit Turnover Certificate issued by C. A., The Average Financial Turnover should not be less than 12 LAKH (with out CA UDIN no. Turnover Certificate will not be Considered)

03. Bidder must submit audited Balance Sheet for the last 3 financial years (2020-21, 2021-22,2022-23). Service contract will not be considered in determining the turnover for eligibility as required above.

04. PAST EXPERIENCE: Bidder should have 3-year Experience.

Bidder must have the following work experience in last 3 financial years (2021-22,2022-23,2023-24) on GeM to any state Govt Department, Hospital/Govt Medical College/Govt Medical Institute.

05. EPBG DETAILS: Electronic Performance Bank Guarantee 5% of estimate bid value required at the time of agreement with winning firm.
