1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. **1. Scope**: The equipment shall be modular in design and capable of performing partial discharge measure ment and analysis on GIS and other types of electrical equipment and components. It is to be used for det ecting different types of defects in Gas Insulated Switchgear (GIS) such as Particles, Loose shields and Part ial Discharges in GIS compartments. (i) \*Manufacturers having credentials of manufacturing required capacity / configuration of the equipment and having network facilities for providing product support in India are entitled to quote against the tender . Whenever as a matter of policy manufacturer does not quote directly, authorized dealer / distributor / Sol e selling agent is also eligible to quote on behalf of their manufacturer.

In such case, the authorized dealer / distributor / sole selling agent shall have to submit relevant "\*\*Author ized Dealership / Distributorship / Sole selling agency" certificate from the manufacturer.
