Buyer Added Bid Specific Terms and Conditions/क्रता द्वारा जोड़ी गई बिड की विशेष शर्तें

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to

increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. **Certificates**

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

3. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Supply Installation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any)

4. **Service & Support**

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

5. **Buyer Added Bid Specific ATC**

1. THE AUTHORIZATION FROM THE DEALER SHOULD BE ATTACHED AT THE TIME OF BIDDING IS COMPULSORY.
2. OEM AVERAGE TURNOVER 25 LAC IN LAST 1 YEAR
3. MAKE IN INDIA CERTIFICATE
 4. BIDDER FINANCIAL STANDING: THE BIDDER SHOULD NOT BE UNDER LIQUIDATION, COURT RECEIVERSHIP, OR SIMILAR PROCEEDING, SHOULD NOT BE BANKRUPT, BIDDER HAS TO UPLOAD UNDERTAKING TO THIS EFFECT WITH BID.
5. BIDDER/OEM MUST UPLOAD ISO 9001:2015
6. WORK ORDER COPY COMPULSORY
7. GEM EXPERT CERTIFICATE MUST UPLOAD BY BIDDER
8. BIDDER TURNOVER 25 LAC IN LAST YEAR
9. THE BIDDER MUST SUBMIT COPY OF ORGANIZATION / FIRM PAN NUMBER
10. THE BUYER RESERVES THE RIGHTS FOR ANY CHANGES/CANCELLATION/REJECTION OF ANY PART OR WHOLE BID, WITHOUT ASSIGNING ANY REASON WHATSOEVER.
11. PROCUREMENT UNDER THIS BID IS RESERVED FOR PURCHASE FROM THE STATE BIDDER
12. ONLY THOSE SUPPLIERS WILL BE CONSIDERED FOR THE BID WHOSE SAMPLE TO BE APPROVED BY THE PURCHASE COMMITTEE
13. NO EXEMPTION ALLOWED IN THIS BID.
14. BIDDER SHALL HAVE TO GET ADVANCE SAMPLE APPROVED FROM BUYER BEFORE BID OPENING DATE. BIDDER SHALL SUBMIT 1 SAMPLE OF EACH ITEM FOR BUYER'S APPROVAL. IF SAMPLE FAILS BY PURCHASE COMMITTEE, THEN BIDDER WILL BE TECHNICALLY DISQUALIFIED NO CLARIFICATION WILL BE GIVEN TO BIDDER WITHOUT ANY REASON.
15. THE BIDDER SHOULD NOT HAVE DEBARRED OR BLACK LISTED OR SUSPENDED OR DEBARRED FROM THE BUSINESS FROM ANY DEPARTMENT OF CENTRAL GOVERNMENT OF INDIA/ STATE GOVERNMENT / PSU/ . DURING THE LAST THREE YEARS FROM THE BID DUE DATE. SEPARATE CERTIFICATE FOR BIDDER SHOULD BE SUBMITTED ON NOTARIZED STAMP PAPER OF RS 100 ALONG WITH

BID SPECIFYING THE DETAIL OF BID AND SHOULD BE ISSUED AFTER THE DATE OF BID .

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
