1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 3. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. #### 12. Warranty

#### 17. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Only Manufacturer or Authorized Dealers with valid dealership certificate from manufacturer (to be sub mitted while bidding) can quote.

2. Inspection: The equipment shall be offered for inspection at manufacturing plant during Manufacturing or Assembly and before dispatch by the representatives of the Executive Engineer. The intimation should be given by the tenderer well in advance, so as to arrange the inspection by the department in time. The same will be inspected by the departmental representative at convenient time at their works. Inspection w ill be carried out before Delivery and on receipt of Goods at site. The Transportation and hospitality arrang ements for inspection team of the Department shall be extended by the tenderer including to and fro trave lling arrangements at free of cost.

3. Delivery: The goods are to be supplied and complete Installation, Testing and commissioning at designa ted Site/Location shall be done within 45 days from the date of Work order with all necessary required co mponents.

4. Mode of Transport: Transportation up to Destination site: The Supplier shall arrange for transportation of goods from works to destination site decided by department, unloading at site in good & undamaged cond ition. The tenderer has to arrange for all the skilled and un skilled labors, heavy crane and all the other ma chinery, tools & tackles etc. if any required for Unloading, Testing & Commissioning of Machine at site.

5. Risk in transit and Transit Insurance: The goods supplied under the contract shall be fully insured by ag ency against any loss or damage incidental to manufacture or acquisition, transportation, storage and deli very to destination.

6. Performance Test: A satisfactory test and trial for performance of rated capacity or at different capacity depending upon the availability of work site for min. 50 working hours/07 days whichever is later should be given by the supplier at site before final acceptance.

#### 7. Payment: a)

7A. 80% of the contract amount shall be paid against receipt of Goods at designated Site in good an d und amaged condition or on inspection of goods at the work shop of manufacturer by the departmental repres entative whichever is convenient to the Department.

7B. Remaining 20% On issuance of satisfactory Test and Trial Performance Certificate by concerned Divisio n/Sub Division mentioned in clause no. 6, 20% of contract price shall be paid.

8. Consignee Delivery and Installation Location: The goods will have to be supplied anywhere in Gujarat st ate as per the Instructions given by Department at the time of delivery. The location/site of the goods to b e supplied will be decided by department later. C onsignee shall have to be contacted and intimated about delivery well in advance.

9. All the consumables for trial run of the machine shall be provided by the concerned bidder/Supplier.

10. TDS/Cess/GST or any other tax applicable shall be recovered/deducted from the bill as per then prevail ing rules in force. 11. Contractor/agency shall be solely responsible for any damage/loss during transportat ion of the parts a nd for that burden of amount and / or any legal proceedings shall be borne by contractor /agency only.

13. The Supplier shall have to alter/replace the Assembly/sub assembly in the warranty period mentioned i n the bid if it is found any design fault while operating Machine as instructed by engineer in charge, Free of Cost.

14. The necessary Power cable, electric and electronic components, change over switch of rated capacity, terminal material-aluminium lugs, Brass glands, End terminal box at the end to connect aluminium lugs & all necessary materials shall need to supply by supplier.

15. Electrical and Electronic connection: The bidder shall have to provide all the required Electrical and Ele ctronic connectio ns, Switches, Switch Gears, Contact breakers, MCB, RCCB. MCCB, ELCB, cables of XPL E S tandard (of make Polycab/RR Cabel/Finolex) and provide secured connection from Control cabin of plant to DG Set.

16. Pre-Delivery Inspection shall be carried out at Manufacturing Plant/Assembly Unit. All the cost of Pre-D elivery Inspection for concerned Inspection team i.e. Transportation (To and Fro), accommodation, any oth er shall only be borne by the bidder.

17. The bidder has to provide Basic maintenance and Repair Training to the Designated buyer representati ves. (Training may be preferably provided at Ahmedabad/Gandhinagar District in Gujarat State.). All the c ost of training shall be borne by the Bidder only.
