not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Buyer Added Bid Specific Scope Of Work(SOW)

SCOPE OF WORK

SCOPE OF WORK FOR AMC PLC SYSTEMS

- The non- comprehensive maintenance contract shall be for the complete PLC system for Electrical system in Ammonia/Urea/SGP.
- It shall cover all system components, hardware, software and communication network [including processor panel and its components, I/O racks at each locations, I/O modules, HMIs, SCADA system -all servers and clients, communication between various workstations including floating clients and web browser, programming (new and modifications), graphics developments (new and modifications) in all stations and HMIs, communication with Ammonia DCS and other equipment's through Ethernet / RS485, Transaction Manager Server and related hardware, software, etc.].
- Contract shall cover two types of services:

[a] Breakdown- Party shall attend to the failures within 24 hrs. of the complaint and at first attend all the problem causing or failed components from readily available spares stock of RCF (removed parts shall be retained by RCF) and bring back the system into normal operation in a shortest possible time. During emergencies, personnel shall be available at site in off late hours & personnel shall complete the maintenance work in hand before leaving the site. Subsequently party shall submit fault analysis report and suggestions and guidelines to RCF Engineers, if any, such that similar faults can be averted.

[b] Preventive Checks - Party shall attend to the system in pre scheduled [quarterly] maintenance visits to conduct regular and routine maintenance check-ups on the system to keep and maintain the system in proper condition. The scheduled visits shall include (but not limited to):

- Check Healthiness of system and take corrective measures.
- Assist in any hardware/component/spares replacement. Spares will be provided by RCF.

- Carry out modifications in logic as per instructions of RCF Engineer In-charge.
 - Review system maintenance (activity) logs.
 - Conduct general physical equipment inspection and cleaning.
 - Perform system diagnostics.
 - Check communication integrity & performance.
 - Carrying out measures for optimum performance e.g. improving scan time, faster communication, flash updates, etc.
 - Check all power supplies & batteries. Checking of various parameters, voltages, etc., healthiness of DI, DO, AI, AO modules, etc.
 - Check and maintain earthing/grounding integrity.
 - Cleaning of panels, filters, fans, etc.
 - Taking backup of PLC logic, SCADA, other necessary applications
 - Any required Up-gradation of PLC firmware/system software/operating system as provided by OEM (installation of any software given as free issue can be carried out).
 - Party shall provide telephonic/virtual support for issues addressed by the RCF Engineer In-Charge.
4. Party shall depute their engineer/s during any unscheduled shutdown maintenance based on mutually agreed dates and also during annual shutdown etc. as per requirement.
 5. Party shall update the documents with all changes carried out during visits. A soft and a hard copy shall be submitted.
 6. Party shall submit a report highlighting the status of the system and offer any suggestion/s for improvements along with each invoice.
 7. Party shall extend its support for site modifications and trouble-shooting of I/O racks and MODBUS devices etc.
 8. Suggestions, if any, for improvement of the system.
 9. Spares required, if any, shall be supplied by RCF. Removed spares shall be retained by RCF.
 10. Payment will be done for no. of visits by service engineer. All payment invoices shall be accompanied with documentary evidence of visit of service engineer (i.e. copy of gate pass, service report, etc.). The per-diem charges for visit includes to-fro charges and other mobilizations charges, if any, for the visit of service engineer.
 11. RCF may provide guest House accommodation on changeable basis, subject to availability.
 12. RCF will provide medical facility up to First Aid only if required.

Tenure of the contract:

The work order shall be valid for a period of ONE year from the 16.08.2024.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
