- MODE OF TENDERING: THROUGH SINGLE TENDER ENQUIRY ON OEM BASIS.
- This tender is being processed on **Single Tender (OEM)** basis with approval of competent authority. The bid will be considered only if it has been submitted by the OEM vendor i.e.

- Solution Bid submitted by other than OEM or its bid specific authorized vendor will not be accepted.
- Scope of work: As per Details in (attached with Tender).
- 1. **PRICE BASIS:** The bidder shall quote on totality basis. The rates quoted by the bidder must be Firm till execution of the contract and inclusive of applicable Taxes & duties. However, specific quantum of Taxe s to be spelt out clearly.
- 2. **NATURE OF CONTRACT:** Maintenance service contract for deputation of service engineer of M/S Reine ke Engineering Pvt. Ltd on chargeable basis for dismantling, cleaning, servicing, refitting and recalibrati on of M/S Reineke Engineering make Electrohydraulic actuators of Turbine Seal Steam (MAW-10) & Lea k Steam (MAW-50) valves of DVC. DSTPS.
- 3. **CONTRACT PERIOD: 300 Days** from the date of actual commencement of work.

The contract may be terminated within the contract period if performance is found unsatisfactory in the opinion of DVC, without showing any further reason.

4. **PAYMENT TERMS:** 95% payment shall be made against RA bills on presentation of bills in triplicate pr e-receipted in original copy after statutory deduction as applicable subject to satisfactory completion of the jobs duly certified by the Engineer-in-charge and execution of the agreement.

Balance, 5% shall be paid after completion of the contract period as well as suitably covering the entire defect liability /guarantee period (if any).

- · Statutory taxes whichever is applicable will be deducted from the bills.

- 5. **PAYMENT TO WORKMEN:** Contactor shall have to make wages / salary payment to workmen within 7<sup>t</sup> of the succeeding month failing which a strict action will be taken against the defaulting contractors. Monthly salary/ wages sheet (one copy) shall have to be submitted to the HR Deptt
- 6. **CONSIGNEE / REPORTING OFFICER/ CONTROLLING OFFICER (officer in-charge):** DGM(E)/Sr. Man ager(C&I), C&I-IPH(E), DSTPS or his authorized representative.
- 7. **LETTER OF AWARD (LOA)/ WORK ORDER (WO):** Prior to the expiration of the period of bid validity, t he Employer (DVC) will notify the successful Bidder through GeM or in writing by letter of empanelment or by telefax to be confirmed in writing by letter, that it has been empanelled. Subsequently, Letter of A ward (LOA)/ WORK ORDER (WO) will be issued. Both Letter of Empanelment and LOA/ WO shall constitute the formation of the contract.

The Vendor shall return the duplicate copy of the Letter of Empanelment / Letter of Award (LOA)/ WORK ORDER (WO) and the other enclosed documents duly signed with seal and date as a mark of acceptanc e, within 10(ten) days from the date of issuance of the order to the Order Issuing Authority.

8. **AGREEMENT**: An agreement in DVC's prescribed format (Enclosed with the BID) shall be executed by the contractor on a non-judicial stamp paper worth Rs. 100.00 (Rupees One Hundred) only.

Contract agreement shall be executed after receipt and verification of the requisite performance securi ty (wherever applicable). The said agreement will be duly signed by the authorized representative of D VC and authorized signatory of Supplier/Contractor/ Service Provider/Consultant.

The Supplier/Contractor/ Service Provider/Consultant should acknowledge and unconditionally accept, si gn, date and return the agreement within 14 days from the date of issue of LOA/PO/Work Order in case of OTE. Such acknowledgements may not be required in low value contract, below Rupees Two and a H alf Lakh or when the bidders offer has been accepted in entirety, without any modifications. If both part ies simultaneously sign the contract across the table, further acknowledgement from the supplier is not required.

Non- execution of Contract Agreement by the Supplier/Contractor/Service Provider within 30 days from the date of issue of LOA/PO/Work Order in case of OTE and 45 days from the date of issue of LOA/PO/Work Order, due to the fault of the Supplier/Contractor/Service Provider, will constitute sufficient ground for forfeiture of its EMD (wherever applicable) and shall short close the Contract and retender and in this retender such defaulting Bidder will not be allowed to participate.

- 9. **SITE MOBILIZATION**: The contractor shall complete site mobilization within a maximum of 15 days afte r getting due intimation in writing from Engineer in Charge, DVC. However, contractor shall compulsoril y engage its manpower for Tit-bit maintenance work and operational support services within 7 days of t he instruction of EIC, DVC.If the contractor fails to mobilize site completely within 15 days, the expendit ure for the period of delay in mobilization beyond 15 days towards engaging the existing contractor or a lternative agency to carry out the contract jobs during that period, shall be borne by the contractor. The expenditure thus incurred shall be recovered from the Running Bill/Bills of the contractor.
- 10. **DEPLOYMENT OF WORKERS/MANPOWER:** The Contractor/Vendor shall ensure deployment of adequ ate nos. of quality manpower (Skilled, Semi-Skilled, helper etc) to be provided as & when required basis with suitable experience having appropriate level of acumen required for the job for rendering satisfactory services and entire satisfaction of DVC (Controlling officer) during the contract period. No child labour shall be engaged by the contractor as per statutory rule of Govt. of India. Contractor shall be held responsible for any delay in execution of work due to non-engagement of adequate and quality manpower. The contractor will take the entire responsibility for the persons deployed by them regarding their accommodation, immediate medical treatment and compensation in case of injury/accident during their stay at the respective station. DVC will have no responsibility whatsoever and will be kept fully indemnified and harmless in this regard. The Staff engaged by the Contractor should not be under addiction of drug / liquor while on duty. It would be obligatory on the part of the Contractor to remove any such persons from the job whose action or conduct in the opinion of DVC management is detrimental to the interest of the Corporation. The contractor shall be fully responsible for his workers regarding terms of employmen

t also. DVC is not responsible in any manner, whatsoever in respect of workers engaged by the contract or for carrying out the work at the respective station of DVC. During execution of the Contract as well as on expiry of the same, the contractor shall ensure that none of their employees/workers claims employ ment in DVC. The contractor while engaging or disengaging their employees/workers shall also follow al I statutory rules & regulations applicable as per workmen's compensation Act. DVC shall not be respons ible for payment towards idle labour charge under any circumstances. Performance of the Contractor shall be evaluated on monthly basis by DVC EIC jointly with the representative of the agency.

- 11. TOOLS &TACKLES: Tools and Plants of all types required for Maintenance as well as restoration of the system need to be provided by the firm. The firm must ensure that the work should not get delayed for deficiency of tools and plants. Engineer-in-Charge reserves the right to instruct for procurement of addit ional tools and instruments if it is felt that tools and plants provided are inadequate for the job. Relucta nce in the part of the firm for providing such equipment's will be viewed as unsatisfactory performance of the firm.
- 12. **SUPERVISION:** The Controlling Officer at his discretion may check/examine the working conditions, any of the tools & tackles of the firm, safety equipment etc. and if found unsatisfactory, he may suspend the job temporary till the measures are taken by the firm. The firm shall be responsible for delay in executi on of the job due to this unsatisfactory working condition/equipment.
- 13. **FORCE MAJEURE:** Vendor shall not be considered in default if delay in delivery occurs due to causes be yond his control such as acts of God, natural calamities, civil wars, fire, strike, frost, floods, riot, and act s of unsurpassed power. Only those causes which have duration of more than seven (7) days shall be c onsidered cause of force / calendar majeure. A notification to this effect duly certified by the statutory a uthorities shall be given by the Vendor to the Owner within 10 days from the date of such Force Majeur e condition by registered letter. In the event of delay due to such causes, the delivery schedule will be extended for a length of time equal to the period of force majeure or at the option of the Owner the ord er may be cancelled. Such cancellation would be without any liability whatsoever on the part of the Owner. However, it will be guided as per Clause No. 16 of GCC of DVC.
- 14. **SAFETY CLAUSES:** The contractor/ agency shall comply with all the requirements of the Factories Act, State Factories Rules as amended time to time, and all other statutory requirements as applicable to hi s work, like Indian Electricity Act, ESI Act (Wherever the facility is available), PF Act, Workmen's Compe nsation Act, Motor Vehicles Act, etc. He shall ensure compliance of all the responsibilities of the Occupie r and Factory Manager as mentioned in the Factories Act, in his activities of work.

Additionally, the contractor shall comply with all the Rules framed by DVC (Also referred here as DVC), relating to Safety of all those working/ present in the workplace, and ensure compliance with all types of permits to work. He shall also comply with all directions given by the Engineer In-charge or Head of DV C Project Safety Deptt. Or, their nominated representative with specific regard to Safety and Health of the workers.

The Contractor/ Agency shall frame and implement its Safety and Health Policy, which shall contain all the provisions relating to compliance of DVC Safety/ Health and Safety Policy.

The Contractor shall appoint a full time Engineer with qualification of either Degree in Engineering, with not less than 1 years of supervisory experience or Diploma in Engineering with not less than 3 years of experience up to 50 workers/ staff or a part thereof. In case of electrical work, supervisor must possess valid supervisory license of competency. In Chemical contract such as chemical laboratory, Supervisor's should have qualification on Bachelor of science with Chemistry with not less than 3 years' experience

If at any time the contractor employs more than 50 workers including staff, he shall appoint from the st art of work itself a Safety Officer, with the qualification as mentioned in the Factories Act/ State Factories Rules applicable to the state, in which the work is carried out. The Safety Officer of the Contractor shall discharge only those responsibilities as mentioned in statutory rules for the Safety Officers.

Before start of work by the Contractor, the Contractor shall sign an MOU with Head of DVC Project Safet y Deptt. and Engineer In- charge of the contract (The Engineer In charge is not below the rank of Suptd. Engineer in Thermal Power Plant and in case of other station Senior Most Engineer). Safety MOU should be prerequisite of agreement of execution. During sign of Safety MOU, agency shall submit following do cuments also:

a. Safety Plan of the Contractor for his own as well as his sub- contractors and action plan to impleme

nt it:

- b. Methodology (Including responsibility) of accident reporting to DVC authorities and Statutory authorities, conduct of enquiries, and implementation of corrective measures.
- c. The Contractor shall get all his Lifting equipments and tackles thoroughly examined / tested throug h a Competent Persons, approved by the local state Government, where the work is being underta ken.
- d. For contracts, before start of work by the Contractor, the Contractor shall purchase new required p ersonal protective equipment's' and get it verified from Head of DVC Safety Department for inspec tion of quality and quantity purchased. He/she will inspect these Safety Shoes, Safety Helmets, Saf ety Harnesses etc. for its suitability. Only after this inspection and clearance in writing, above refer red items shall be used or issued by the Contractor. For contracts, more than one-year, new PPEs again shall be distributed before expiry of one year from last PPEs distribution date. After that, con tractor shall also have to provide different kind of safety gears according to their nature of job including reflective jackets.
- e. The cost of these PPEs are treated under chargeable expenditure for which there is the cost of thes e PPE should be estimated in line with para 2.11.1 (statutory and non -statutory consideration whil e working out estimate page no. 60) of IR and compliance Hand Book-2015 (1st edition). Tenure of these three Personal Protective Equipment's shall be applicable once for those numbers working fo r one year, if these are purchased from the party with which the rate contract had been made by D VC; at the rate at which rate contract had been made by DVC; or from the original IS Marked equipment manufacturer (Or his authorized representative), registered with Bureau of Indian Standard. The estimated value of Safety Shoes and Safety Helmets shall be limited to the number of employ ees, for which the contractor had taken the labour licence or DVC had approved to hire; for the Safety Harness payment in estimated value shall be restricted to the decided quantity between the C ontractor and DVC
- f. Before Start of the contract, the Contractor shall provide appropriate Safety Induction Training to al I his workers, of at least one full day duration, through an external agency with faculty having the qualification as mentioned in the factories act /state rules for the safety officer. The DVC Managem ent has a right to refuse issuance of gate pass to the workers, if the workers are not trained.
- g. Before Start of the work by the Contractor, the Contractor shall provide thorough pre- employment health check-up /examination of his workers and fitness certificate as per the Factories Act and Rul es made under. Later, DVC shall provide Occupational Health Check Up such as lung function test, ECG, Sputum, Chest X-ray, audiometry, blood test etc. of all contract workers including i.e. supply, casual, AMC/ARC workers working within the Thermal Power Plant and Audiometric test, ECG, Blood test etc. for Hydel station with cashless facility. Only those workers who are found fit in such medical examination shall be employed only by the Contractor. It is the responsibility of each contracting agency to ensure the availability of suitable arrangements at their work site for rendering prompt and efficient First aid to injured persons. The DVC Management has a right to refuse issuance of gate pass to the workers if the workers are not undergone such pre-engagement medical examination /health check-up.
- h. In case of occurrence of any accident/ mishap/ violation of statutory provisions/ DVC Rules, Compet ent authority in DVC may constitute inquiry Committee, to find out the circumstances or causes int o it, remedial measures to prevent recurrence of similar accidents/mishaps/ violations etc. The Con tractor shall provide full cooperation in conduct of inquiry, conducted by such Inquiry Committee a nd also send his workers to attend the inquiry and give statement, with full wages for the day.
- i. Wherever there is probability of fall of worker/ material from more than 8 Ft, to prevent his fall, the contractor shall provide Full Body Safety Harness with ISI mark to all his workers and ensure it's us e. He shall also provide safety net below such work place. He shall ensure compliance of all provisi ons of Permit for working at height advised by DVC. If the fall arrester is provided by DVC, the Cont ractor shall ensure it's right use.
- j. Before execution of safety MOU all statutory documents related to vehicles used like vehicles fitnes s, RC book, driving license, pollution certificate, driver eyesight test etc. should be prerequisite.
- k. Other important guidelines of Safety aspects of the contract shall be guided as per DVC GCC (attac hed in GeM bid & also available in <a href="http://www.dvc.gov.in/dvcwebsite\_new1/conditions-of-contract/">http://www.dvc.gov.in/dvcwebsite\_new1/conditions-of-contract/</a>.)

#### **DETAILED SAFETY CLAUSE**: As per attached DVC GCC.

- 15. **WORKERS' COMPENSATION:** All the workers under the contract must be paid compensation as per W orkmen's Compensation act in case of injury or death in course of employment while on duty, by the co ntractor at his own cost. The contractor shall be solely and wholly responsible for any accident that ma y occur during execution of the work and for injury to person/persons or damage to the property of any description whatsoever caused during the execution of the work. In the event of any such accident, the contractor shall be responsible and shall pay proper compensation for the same as per Workmen's Com pensation Act. The contractor shall keep the occupier i.e., DVC safe, harmless, and indemnified against all claims and expenses, for any such damage or injury etc. to any person or property. In case of any accident of contractor's workmen, contractor is to arrange necessary prima facie requirement immediately after the incident. DVC shall in no way be held responsible to compensate contractor workmen be it on duty or not. No benefit in any form shall be admissible in such case. The contractor should take care for safety of equipment and property of DVC. Any loss to this effect will be contractor's responsibility entirely and they shall have to make good for the losses and extra expenditure incurred by DVC thereof. Responsibility of the spares & materials rests with the contractor himself. Contractors have to replenish the same at his own cost & risk in case of loss/damage of the spare/material under his custody.
- 16. **EPF/ESI:** Compliance of EPF & ESI scheme for the workers engaged by the Contractor shall be applicable as per rules.
- 17. **LD CLAUSE:** It will be binding to the contractor to maintain the equipment in healthy condition within th e time as directed by the Engineer-in-charge, DVC. In case of delay in executives of work attributable to the contractor, DVC reserves the right to recover a sum equivalent to 0.5% of the value of the delayed work for each week of delayed part thereof of the respective station subject to maximum of 10% of the t otal value of order of that station.
- 18. **SUB-LETTING:** The vendor shall not sublet any part of the contract to any other vendor/agency without the prior written consent of the owner. Such assignments or subletting or transfer shall not relieve the vendor from any obligation, duty and responsibility under this contract. Any assignment, transfer subletting without the prior approval of the owner shall be void. The owner shall have the right to cancel the or der/contract and get the services from elsewhere and the vendor shall be liable to the owner for any loss or damage which the owner may sustain in consequence or arising out of such contract and the vendor shall indemnify such loss or damage to the owner.
- 19. **LIMITATIONS OF LIABILITY:** Except in cases of Criminal Negligence or wilful misconduct, The Contract or and the Employer shall not be liable to the Other Party for any indirect or consequential loss or dama ge, loss of use, loss of production, or loss of profits or Interest costs, provided that this exclusion shall n ot apply to any obligation of the Contractor to pay liquidated damages to the Employer.

#### AND

The aggregate liability of the Contractor to the Employer, whether under the Contract, in tort or otherwise, shall not exceed the total Contract Price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment, or to any obligation of the Contractor to indemnify the Employer with respect to patent infringement, copy right, workman compensation.

20. LABOUR LAWS & REGULARITIES: The obligation of the contractor in respect of provisions of all laws, r ules, orders and regulations and notifications whether Central or State or Local as applicable to him or t o the agreement from time to time.

Bidder has to comply provisions of labour laws and rules applicable as per appropriate Govt. i.e.

- a. Contract Labour (R&A) Act & Rules thereof i.e.
  - i. Wages-cum-Master Roll Register
  - ii. Master Roll
  - iii. Register of wages
  - iv. Register for deduction of damages or loss.
  - v. Register for fines.
  - vi. Register for Advance.
  - vii. Register for over time.

- viii. Register for workmen employed by the contractor.
  - ix. Employment Card.
  - x. Wage slip of the contractor's workers, and
  - xi. Half yearly return etc.
- b. Minimum Wages Act: Payment of wages will be made as per notification of Minimum Wages notified by Appropriate Govt. time to time.
- c. EPF Act. You have to comply all provisions of EPF Act & payment of employer's contribution and oth er charges under the Act.
- d. Workmen's Compensation Act.: You will be solely and wholly responsible for any accident that may occur during execution of the work and also for injury to the workmen engaged by you. In the even t of fatal accident / disability you will have to pay compensation as per Workmen's Compensation Act/Factories Act.
- e. Payment of Bonus Act.
- f. Factories Act and Rules.
- g. Industrial Dispute Act.
- h. Any other statutory provisions
- 21. **CONTINGENCY**: Contractor must possess sufficient fund to pay the workers when bills are not paid/pass ed for reasons whatsoever for at least two months.
- 22. **CONTRACTORS PERFORMANCE EVALUATION:** In order to have smooth progress of the work, there is a need for contractors who will execute the job in time and as per stipulated specification quality in the Contract. In order to ensure the same, a standard evaluation format has been framed (Refer Bid Form s). The Project Manager of DVC/Engineer-In-Charge will fill in the details as per format enclosed, which is to be signed by the authorized representative of the Contractor (Owner/proprietor/site in Charge). If the contractor refuses to sign, the evaluation of engineer in charge will be final. The performance rating as emerged out will be kept in the system. In case Performance Rating obtained above is "Unsatisfactory" twice consecutively, the Contractor shall not be recommended for issue of the enquiry for a period as deemed fit not more than 2 years. In case performance of any Bidder in any of the previous Contract of the Employer during the last 2 years is found "Unsatisfactory", the Employer (i.e. DVC) reserve the right to consider the bidder ineligible for participating in this tender and in such case no bidder/intending bidder shall have any claim arising out of such action.
- 23. **PAYING AUTHORITY:** The Bill is to be raised to the **Sr. Manager (Finance), DSTPS Unified Account s, DSTPS, DVC, ANDAL, Paschim Bardhaman, W.B. Pin-713512.** duly certified by the concerned Consignee/Engineer in Charge or his authorised representative.

- 25. **PAYMENT THROUGH RTGS/NEFT**: All payments to you will be released through RTGS/NEFT only. You must submit the requisite details as asked for payment.
- 26. TERMINATION CLAUSE Termination of contract will be applicable as per Clause No. 17 read with clause sl. No. 24 of OPTIONAL TERMS & CONDITIONS OF CONTRACT of GCC. GCC-2022 is available in DVC web site
- 27. **SETTLEMENT OF DISPUTES AND ARBITRATION** Any dispute(s) or difference(s) arising out of this NIT & subsequent contract shall, to the extent possible, be settled amicably between DVC and the Power Tr ader.

In the event of any dispute or difference whatsoever arising under the NIT & subsequent contract or in c onnection therewith including any question relating to existence, meaning and interpretation of the con tract or any alleged breach thereof, the same shall be referred to the Chairman of Damodar Valley Corp oration, Kolkata-54 or to a person nominated by him for arbitration. The Arbitration shall be conducted i

n accordance with the provisions of arbitration and conciliation law 1996 or latest and the decision/ judg ment of Arbitrator/Arbitrators shall be final and binding on both DVC and the contractor.

However, in case the Contractor will be a Central Public Sector Enterprise/ Govt. Department, the disput e arising between DVC and the Contractor shall be settled through Permanent Arbitration Machinery (P AM) of the Department of Public Enterprise, Govt. of India as per prevailing rules.

All suits arising out of the NIT & subsequent Contract, If any, are subject jurisdiction of Court in the City of Kolkata {South 24- Parganas, New Alipore Court (India)} only and no other Court, when resolution/s ettlement through mutual discussion and arbitration fails.

- 28. **GOVERNING LAWS:** The Contract shall be governed and interpreted in accordance with laws in force in India. The Court in the City of Kolkata {South 24- Parganas, New Alipore Court (India)} only shall have e xclusive jurisdiction in all matters arising under the contract.
- 29. **Any Other Terms and conditions** which are not specifically mentioned in the Terms and conditions of the GeM BID/NIT & ATC (document attached) shall be guided by GeM GTC and DVC's G.C.C as per appli cability.
