- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buver.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

4. Service & Support

5. Service & Support

6. Service & Support

7. Service & Support

The Service Provider is required to have at least 20 % of the required manpower on service provider's payroll for at least one year. Necessary documents relating to such manpower will be uploaded by the bidder for verification of the buyer. Such manpower will be part of total manpower to be provided by the Service Provider in case he gets the contract against this bid.

8. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

9. Certificates

- 3. Preference will be given to bidders stationed at Hyderabad for Administrative Convenience.

- 4. ISO 9001: The bidder of the offered service must have ISO 9001 certification. Documentary evidence to be furnished.
- 5. The service provider is responsible for supplying cleaning material/consumables and equipment as per the customized list as depicted in the Table-A (PRICE LIST FOR CLEANING MATERIALS FOR COMP OSITE TENDER FOR HIRING OF SANITATION SERVICE IN THE O/O AG(A&E), TELANGANA).

- 7. Cleaning material/consumables and equipment of acceptable quality, as mentioned in the bid docu ment, and quantity as specified against each item, are to be supplied to this office every month. The quantities mentioned for each item of cleaning material/consumables and equipment for each month/year are only tentative requirements, not exhaustive, and may vary depending upon the actual needs.
- 8. The Total carpet area of this office is 2,15,000 Sqft (includes 80 washrooms).
- 9. The bidders are required to quote the cost of cleaning material/consumables and equipm

- 10. Required number of cleaning material/consumables and equipment have to be maintained in the off ices , at all times, and a record of all these items should be kept by the Supervisor of housekeeping staff, which will be subject to inspection by designated officer of this office.
- 11. There will be no compromise on the quantity and quality of cleaning material/consumables and equi pment. Any quote pertaining to the cleaning material/consumables and equipment which is unreaso nably low a s per the decision of the competent authority of this office, will be summarily rejected. H ence, the agencies shall observe strict diligence while quoting reasonable amount for cleaning material/consumables and equipment. The cost of cleaning material/consumables and equipment should be inclusive of all applicable taxes.
- 12. Service provider must maintain a stock of 25% of the quarterly requirement of cleaning material/con sumables and equipment at this office all the time.
- 13. The payment to the selected bidder will be made monthly as per the invoice Submitted by the select ed bidder immediately in the following month. This invoice must depict the wage and consumables/ equipment separately. The wage component of the bill must be as per the attendance and the cons umable/equipment component must be as per the actual usage and supporting records.
- 14. Hired personnel may be called to work beyond normal working days based on pending work load. Pa yment for the additional number of days engaged, if any, shall be made based on the attendance as per the Minimum Wage applicable.
- 15. The term "Seller" in the bid is synonymous to Service provider/agency/bidder/vendor. The term "Bu yer" is synonymous to Purchaser/office.
- 16. This office reserves the right to reject the quotation/ bid of any Service Provider/Agency which does not comply with any of the above clauses.

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
