contract at the contracted rates. Bidders are bound to accept the orders accordingly.

- 1. This tender is floated for OEM M/s ABB India Ltd and only they are allowed to participate. Any other bidder shall be straight away rejected.

- 4. For billing, a separate BPCL PO shall be issued and payment will be processed as per BPCL proce ss. GEM PO shall be formal and legal PO.
- 5. All terms and conditions shall be as per BPCL GCC and no other terms as per bidder's organization shall be accepted.
- 6. Prices shall be inclusive of taxes and duties.
