OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

3. Scope of Supply

Warranty period of the supplied products shall be as given in specifications from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. - 6. Agency should mention Make/Model of the quoted items.

- 7. Agency should submit duly filled supplier compliance (Annexure-II) for commercia I terms and conditions in the technical bid.
- 8. Successful tenderer shall furnish the operation & maintenance manuals, Guarantee certificate and tes t certificates, etc., along with the materials.
- 9. Submission of tender by the tenderer implies that he has read the instructions and all contents of ten der documents and made himself understood/well versed with the scope & specifications called for th e tender.
- 10. Since the evaluation is a total value evaluation basis, agency requires to quote for all the items menti oned in the BOQ. If agency fails to do so in such case, the offers of those agency bids are not consider ed for further processing.
