#### 1. Generic

However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

- 1. EMD of Rs.3,00,000/- of the tender estimate value in the form of Demand Draft / Banker's Cheque / Bank Guarantee/ electronics Bank Guarantee under structured Financial messaging system (SFMS) from any of the scheduled banks drawn in favour of "NIELIT HQ, Delhi" is required to be submitted by the bidder on or before the closing date and time of e-submission of online e-bid to NIELIT HQ, Delhi, failing which the bids will not be considered.
- 2. The final selection of the agency shall be on QCBS basis in the ratio of 70:30 as per GeM calculation.

### Disclaimer/अस्वीकरण

- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
