- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. - 7. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 9. #### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

# ADDITIONAL TERMS AND CONDITIONS FOR PROCUREMENT OF PRINTED ADDRESS STICKERS FO R DAVP FOR 01 YEAR

- 1. Buyer reserves the right to cancel the bid any time without assigning any reason.
- 2. Bidder should upload one certificate to include the additional terms and conditions (ATC) stating that seller is accepting all terms and conditions, specification parameters mentioned for the bid. I f a bidder didn't upload this certificate, the bid will be summarily rejected during technical evaluation with /without assigning any reason.
- 3. To get the purchase preference in MSE/MII (First Class Supplier) category, Bidder is required to a pply in the same category on GeM and to upload relevant certificates issued by the appropriate authority while participating in the Bid. No purchase preference will be awarded in case of non c ompliance of above.
- 4. Successful bidder will have to deposit performance security within 7 days from the date of awar

d of the contract.

- 5. Liquidated Damages for the delay in delivery of goods will be deducted from bidder's bill as per Gem Portal General Terms & Conditions.
- 6. Bidder has to supply the whole quantity within the stipulated time and at venue mentioned in Bi d. Delay in supply will attract 0.5% penalty per week. The calculation will be done for the whole of the week or part thereof.
- 7. (A) The requirement to be fulfilled is both stickers & address printing thereof in a cycle of 15 Day s.
  - (B) For every fortnight, the data for printing on self adhesive sticker will be provided through em ail (soft copy) and whole quantity of every fortnight is required to be delivered within 7 days from the date of issuing the supply order / email.
- 8. Payment for the purchase would be made only after successful completion of supply and subject to availability of funds.
- 9. Supply and transportation: Seller will arrange to dispatch the material through their authorized t ransporter on door delivery basis. Loading and unloading of material shall be in scope of seller (i ncluding all taxes).
- 10. Material Inspection will be done only after completion of supply as per delivery schedule in fortn ight. In case of more than one material inspection are to be done due to operational requirement of department 1% penalty will be imposed on supplier.

#### 11. Rejection of material:

- i) If the delivered product/ part of product are not found according to requisite quality/ specificat ions then the product/part of product will be confiscated.
- ii) If the Material supplied do not confirm to the specification laid down in the tender the Depart ment reserves the right to reject the material. For the rejected material, no payment will be m ade and the supply will be confiscated.
- iii) In addition, in the event of delivery of any defective/sub-standard supply, which owing to urge ncy or for any other reason cannot be wholly rejected, the Department shall have the power to deduct from any payment due to the supplier such amount as penalty subject to maximum pe nalty of 10%. - 12. Payment of the supplies will be made on completion of total quantity as per delivery schedule a nd after necessary material inspection approved by competent authority.
- 13. After issuing of purchase order to the approved bidder if he fails to execute the supply order or d eny supplying the ordered quantity, in such case the Department shall recommend to GeM for d ebarring such bidders from participation in the bids at least for one year. In addition, if the appro ved bidder accepts the extended bid offer validity after its expiry and fails to execute the purcha se order issued to him, it will also be liable to be recommended for one year debarment by GeM apart from other action as prescribed in GFR 2017 and other relevant procurement rules issued by Government from time to time.

#### 20. FORCE MAJEURE (FM)

A Force Majeure (FM) means extraordinary events or circumstances beyond human control, such as an event described as an act of God (like a natural calamity) or events such as a war, strike, riots, crimes (but not including negligence or wrong-doing, predictable/s easonal rain and any other events specifically excluded in the clause). An FM clause in the contract frees both parties from contractual liability and obligation when prevented by such events from fulfilling their obligations under the contract. An FM clause does not entirely excuse a party's non-performance but only suspends it for the duration of the FM. The firm must give notice of FM within a reasonable time as the conditions permit (say, not later than 14 days after its occurrence), and it cannot be claimed ex-post facto. There may be an FM situation affecting the purchase organization only. In such a situation, the purchase organization is to communicate with the supplier along similar lines as above for further necess ary action. If the performance in whole or in part or any obligation under this contract is prevented or delayed by any reason of FM for a period exceeding 90 (ninety) days, either party may, at its option, seek to terminate the contract without any financial repercussion on either side.

- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
