4. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid

Any defects noticed during the warranty period shall have to be rectified or materials replaced at your cost. Materials not conforming to specifications shall be rejected and returned to the supplier at their risk and cost.
- b) The item shall be warranted to be free from defects in design, material and workmanship for a satisfactory operation during the warranty period. The bidder shall warranty for prompt repair and / or replacement at site free of cost if any part of the machine is found to be defective in design, material or workmanship during the warranty period. The warranty shall not apply to normal wear and tear of component parts. Warranty certificate must be submitted by Successful Bidder at the time of delivery of Goods.

6. **Inspection:** -
