- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Any defects noticed during the warran ty period shall have to be rectified or materials replaced at your cost. Materials not confirming to specifications shall be rejected and returned to the supplier at their risk and cost.
- b) The item shall be warranted to be free from defects in design, material and workmanship fo r a satisfactory operation during the warranty period. The bidder shall warranty for prompt repair and / or replacement at site free of cost if any part of the machine is found to be defective in design, material or workmanship during the warranty period. The warranty shall not apply to normal wear and tear of component parts. Warranty certificate must be submitted by Successful Bidder at the time of delivery of Goods.
