- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.   6. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE
- bidder subject to acceptance of L1 bid price.

  7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc.

  This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of

quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

#### 1. Buyer Added Bid Specific ATC

#### **ADDITIONAL TERMS AND CONDITIONS OF THE GEM BID DOCUMENT**

The Bidder is required to give confirmation of their acceptance of the Additional Terms and Conditions of the GeM Bid Document mentioned below which will auto matically be considered as part of the Contract concluded with the successful Bidder (i.e. Seller in the Contract) as selected by the Buyer. Failure to do so may result in rejection of the Bid submitted by the Bidder.

- 1. <u>Payment Terms</u>. It will be mandatory for the Bidders to indicate their bank acc ount numbers and other relevant e- payment details so that payments could be made thro ugh ECS/EFT mechanism instead of payment through cheques, wherever feasible. A copy of the model mandate form prescribed by RBI to be submitted by Bidders for receiving payments through ECS is at Form DPM-11 (Available in MoD website and can be given on request). The payment will be made 100% post completion of works.
- 2. <u>Limitation of Liability</u>. Except in cases of criminal negligence or wilful miscon duct, the aggregate liability of the contractor to the Procuring entity, whether under the con tract, in tort or otherwise, shall not exceed the total Contract Price, provided that this limita tion shall not apply to the cost of repairing or replacing defective equipment, or to any oblig ation of the contractor to indemnify the procuring entity concerning IPR infringement.
- 3. **Advance Payments**. No advance payment(s) will be made.
- 4. **Paying Authority**. The payment of bills will be made on submission of the follo wing documents by the Seller to the Paying Authority (Accounts Office, Karwar) along with the bill: -
- (a) Ink-signed copy of contingent bill / Seller's bill.
- (b) Ink-signed copy of Commercial invoice / Seller's bill / e-invoice.
- (c) E-Invoices to be generated on AO(Kar) GST No. 29BLRA16713E1DF.
- (d) Copy of Contract with U.O. number and date of IFA's concurrence, (where required u nder delegation of powers).
- (e) CRVs in duplicate countersigned by Manager (Material).
- (f) Inspection note.
- (g) Claim for statutory and other levies to be supported with requisite documents / proof of payment such as GST paid Receipt and Undertaking, Proof of payment for EPF/ESIC contribution with nominal roll of beneficiaries, Excise duty challan, Customs duty clearance certificate, Octroi receipt, etc as applicable.
- (h) Exemption certificate for Excise duty / Customs duty, if applicable.
- (j) Bank guarantee for advance, if any.
- (k) Guarantee / Warranty certificate.
- (I) Performance Bank guarantee / Indemnity bond where applicable.
- (m) DP extension letter with CFA's sanction, U.O. number and date of IFA's concurrence, where required under delegation of powers, indicating whether extension is with or without LD.
- (n) Details for electronic payment viz Account holder's name, Bank name, Branch name and address, Account type, Account number, IFSC code, MICR code (if these details are not incorporated in contract).
- (p) Any other document / certificate that may be provided for in the supply order / contr act.
- (q) User Acceptance.
- (r) Xerox copy of PBG.

(Note – From the above list, the documents that may be required depending upon the pecul iarities of the procurement being undertaken, may be included in GeM Bid Document)

- 5. **<u>OEM Certificate</u>**. In case the Bidder is not the OEM, the agreement certificate with the OEM for sourcing the spares shall be mandatory. However, where OEMs do not exist, mi nor aggregates and spares can be sourced from authorized vendors subject to quality certification.
- 6. **Export License**. The Bidders are to confirm that they have requisite export licens e from their Government and Authorization from the manufacturing plant, in case they are not the OEM, to export the military / non-military goods to India.
- 7. **Quality**. The quality of the stores delivered according to the present Contract shall c orrespond to the technical conditions and standards valid for the deliveries of the same stores for in Seller's country or specifications enumerated as per GeM Bid Document and s hall also include therein modification to the stores suggested by the Buyer. Such modifications will be mutually agreed to. The Seller confirms that the stores to be supplied under this Contract shall be new i.e. not manufactured before (Year of Contract), and shall incorporate all the latest improvements and modifications thereto and spares of improved and modified equipment are backward integrated and interchangeable with same equipment supplied by the Seller in the past if any. The Seller shall supply an interchangeability certificate alon g with the changed part numbers wherein it should be mentioned that item would provide as much life as the original item.
- 8. **Quality Assurance**. Seller would provide the Standard Acceptance Test Procedure (ATP) within **01** month of this date of contract. Buyer reserves the right to modify the ATP. S eller would be required to provide all test facilities at his premises for acceptance and insp ection by Buyer. The details in this regard will be coordinated during the negotiation of the contract. The item should be of the latest manufacture, conforming to the current production standard and having 100% defined life at the time of delivery.
- 9. <u>Inspection Authority</u>. The Inspection will be carried out by NSRY, Karwar. The mo de of Inspection will be Departmental Inspection. Items supplied will be taken on charge th rough joint muster of items by representatives of concerned department and Material Department.
- 10. Warranty. Except as otherwise provided in the invitation tender, the Sellerhereby de clares that the goods, stores articles sold/supplied to the Buyer under this Work Order shall be of the best quality and workmanship and new in all respects and shall be strictly in acco rdance with the specification and particulars contained in Work Order. The Seller hereby gu arantees that the said services would continue to conform to the description and quality afo resaid for a period of 06 months and the said goods stores/articles would continue to confor m to the description and quality aforesaid for a period of 12 months from the date of delive ry of the said goods stores/articles to the Buyer and that notwithstanding the fact that the Buyer may have inspected and/or approved the said goods/stores/articles, if during the afo resaid period of 06/12 months the said goods/stores/articles be discovered not to conform t o the description and quality aforesaid not giving satisfactory performance or have deterior ated, and the decision of the Buyer in that behalf shall be final and binding on the Seller an d the Buyer shall be entitled to call upon the Seller to rectify the services/ goods/stores/arti cles or such portion thereof as is found to be defective by the Buyer within a period of days, or such specified period as may be allowed by the Buyer in his discretion on applicati on made thereof by the Seller, and in such an event, the above period shall apply to the ser vices/goods/stores/articles rectified from the date of rectification mentioned in warranty the reof, otherwise the Seller shall pay to the Buyer such compensation as may arise by reason of the breach of the Warranty therein contained.
  - (a) Guarantee that they will supply spare parts, if and when required on agreed

basis for an agreed price. The agreed basis could be and including but without any li mitation an agreed discount on the published catalogue or an agreed percentage of profit on the landed cost.

- (b) Warranty to the effect that before going out of production for the spare parts they will give adequate advance notice to the Buyer of the equipment so that the lat ter may undertake the balance of the life time requirements.
- (c) Warranty to the effect that they will make available the blue prints of drawin gs of the spares if and when required in connection with the main equipment.
- 11. **Applicable GST Rates**. All bidders are required to verify the applicable GST rates for the services and spares they intend to supply. Bidders must quote their prices inclusive of the applicable GST rates as specified below: -
  - Services and Spares for onboard Indian Naval Ship / Submarine: GST applicable at the rate of 5%.
  - Services and Spares for Yard Premises: GST applicable at the rate of 18%.
- 12. **Performance Guarantee**. The bidder will be required to furnish a Performance Gu arantee by way of Bank Guarantee through a public sector bank authorized to conduct gov ernment business (ICICI Babk Ltd., Axis Bank Ltd. or HDFC Bank Ltd.) for a sum equal to 5% of the contract value within 30 days of receipt of the confirmed order. Performance Bank G uarantee should be valid up to 60 days beyond the date of warranty. The specimen of PBG i s given in Form DPM-15 (Available in MoD website and can be provided on request).
- 13. **Earnest Money Deposit**. Bidders are required to submit Earnest Money Deposit (E MD) for amount of 3% along with their bids. The EMD may be submitted in the form of an A ccount Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee fr om any of the public sector banks or in MOD website and can be provided on request). EMD is to remain valid for a period of forty-five days beyond the final bid validity period. EMD of the unsuccessful bidders will be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract. The Bid Security of the successful bidder would be returned, without any interest whatsoever, after the receipt of Performance Security from them as called for in the contract. EMD is not required to be submitted by those Bidders who are registered with the Central Purchase Organization (e.g. DGS&D), National Small Industries Corporation (NSIC) or any Department of MoD or MoD itself. The EMD will be forfeited if the bidder withdraws or amends, impairs or derogates from the tender in any respect within the validity period of their tender.

#### 14. Minimum Qualification Requirement.

(i) **Financial Capacity**. Bidder should have average annual turnover of Rs. 10,01,036.00 annually over the last three financial yea years, ending 2024. Towards this, CA audited balance sheet and IT return is required to be submitted along with the Technical Bid.

#### AND

(ii) **Technical Capacity.** The Bidder should qualify in any of the following cri teria, and towards the same, work orders and work completion certificates are requir ed to be submitted along with technical bid: -

(aa) The bidder should have executed contracts in the field of Repair/ Servi ceability checks of Radar, System integration and Installation of Radar, as the fitment entails specific technical understanding of the radar system onboard I N/ CG ships during last 03 years with work completion certificate as per table below:

- (iii) On-Site Visit Certificate. All prospective bidders are required to conduct an on-site visit to the project location prior to submitting their bids. This visit is intended to ensure that bidders fully understand the scope of work and the conditions under which the work will be performed. During the on-site visit, a designated represent ative from the department will be present to guide and provide necessary clarifications. Upon completion of the visit, the department representative will issue an On-Site Visit Certificate. This certificate, signed by the department representative, is mandatory and must be included in the bid submission package. Bidders must schedule their on-site visit at least 3 days before the bid submission deadline. Failure to submit the signed On-Site Visit Certificate at the time of tendering will result in the bid being considered non-compliant and subsequently rejected.
- 15. The Bidder is required to give confirmation of their acceptance of the standard condit ions of the ATC. Failure to do so may result in rejection of the bid submitted by the Bidder.
- 16. Bidder's offer is liable to be rejected if they don't upload any of the certificates/ documents sought in the bid document, ATC and corrigendum if any.

# Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्तें</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
