- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of

quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

- 6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

A. PRICE BASIS:

The rates quoted by the bidder in GeM portal must be Firm till execution of the contract and on FOR De stination Basis in INR currency and that will be inclusive of Packing & Forwarding charges and Freight c harges (if any) etc. for supply and inclusive of Goods and Services Tax (GST) for both supply and works.

B. LD CLAUSE:

The time remains the essence of any contract/ purchase order awarded by DVC and all supply under a Purchase Order/all deliverables under a Work Order needs to be completed within the stipulated time s chedule. The Contractor shall commence work on the Facilities from the date of Notification of Award. T he Contractor shall thereafter proceed with the Facilities in accordance with the time schedule specified in Time Schedule to the Contract Agreement. Therefore, the provision has been kept in the contract that in case of delay in completion/delivery, for the reasons attributable to the contractor/ vendor, owner r eserves the right to recover from the contractor/vendor, a sum equivalent to 0.5% of the value of the de layed materials / equipment / spares / work for each week of delay and part thereof subject to maximum of 10% of the total value of the order as Liquidated Damage (LD).

In cases, where the works/supply/services extend beyond the contractual completion schedule/delivery period and provisional extension order is issued without deciding on the application of LD, no amount fr om the RA bill will be deducted as "withheld LD" amount in case where adequate retention payment (ov er and above SD) remains with DVC as per terms of the contract.

C. RISK PURCHASE CLAUSE:

- i. Alternatively, the Purchaser reserves the right to purchase the material from elsewhere at the sole risk and cost of the Vendor and recover all such extra cost incurred by the Purchaser in procuring the material by the above procedure.
- ii. Alternatively, the Purchaser may cancel the Order completely or partly without prejudice to his right un der the alternatives mentioned above.
- iii. In the event of recourse to alternative (i) and (ii) above, the Purchaser will have the right to repurchase t he stores, to meet urgency in requirement caused by Vendors failure to comply with the schedule of delive ry irrespective of the fact whether the materials are similar or not.

D. FORCE MAJEURE CLAUSE:

Vendor shall not be considered in default if delay in delivery occurs due to causes beyond his control su ch as acts of God, natural calamities, civil wars, fire, strike, frost, floods, riot and acts of unsurpassed po wer. Only those causes which have duration of more than seven (7) days shall be considered cause of f orce /calendar majeure. A notification to this effect duly certified by the statutory authorities shall be gi ven by the Vendor to the Owner within 10 days from the date of such Force Majeure condition by regist ered letter. In the event of delay due to such causes, the delivery schedule will be extended for a lengt h of time equal to the period of force majeure or at the option of the Owner the order may be cancelled. Such cancellation would be without any liability whatsoever on the part of the Owner. In the event of su ch cancellation, the Vendor shall refund any amount advanced or paid to the Vendor by the Purchaser a nd deliver back any materials issued to him by the Purchaser and release facilities, if any, provided by the Purchaser.

- **E.** Payment term for supply of materials: 100% payment will be released within ten (10) days of issue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills.
- **F.** Payment terms of the works: 95% payment on the executed work shall be ma de against RA bill after satisfactory completion of work, duly certified by the DVC E ngineer-in-charge, and on submission of bills in triplicate, duly pre received, and u pon prior compliance of Security Deposit Clause and execution of the Agreement in DVC format (if applicable). Remaining 5% will be paid after completion of contract period.

Goods supplied will always be subject to our inspection on arrival at the destination.

J. TRANSIT INSURANCE:

Arrangements for transit insurance can be made by DVC as per Mega Risk Policy arranged with existing underwriter as per time being imposed.

K. GUARANTEE/WARRANTY:

All equipment & devices along with structures will be covered by a Guarantee/ Warranty for 12 months from the date of commissioning or 18 months from the date of supply whichever is earlier. Any defect o r damage in supply, erection & commissioning found within Guarantee/ Warranty period, it must be repl aced/ rectified by the party at their own cost and arrangement.

L. LIMITATIONS OF LIABILITY:

Except in cases of Criminal Negligence or wilful misconduct, (i) The Contractor and The Employer shall not be liable to the Other Party for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or Interest costs, provided that this exclusion shall not apply to any obligation of the Contractor to pay liquidated damages to the Employer AND (ii) The aggregate liability of the Contractor to the Employer, whether under the Contract, in tort or otherwise, shall not exceed the total Contract Price, provided that this limitation shall not apply to the cost of repairing or replacing defect ive equipment, or to any obligation of the Contractor to indemnify the Employer with respect to patent infringement, copy right, workman compensation.

M. INSPECTION:

- **a.** Pre dispatch Inspection (PDI) of the material shall be done at Vendors works jointly by DV C and vendor representatives before dispatch of the materials.
- **b.** Inspection of materials will be carried out, after arrival of the materials at MTPS site, by a uthorized representative of DVC in presence of authorized representative(s) of the party. J oint Inspection will be carried out in line with the Packing List and Bill of Quantity furnished by the party along with supply.

All materials to be manufactured/ supplied by you against this enquiry shall be subject to inspection after arrival at site, check and/or test by the purchaser or his authorized representative. If upon delivery, the material does not meet the specifications the material shall be rejected and you will be intimated for repair/modify or for replacement. In such cases all expenses including to-and-fro freight, repacking charges etc., if required shall be to your account.

N. PACKING AND MARKING:

All goods shall be securely packed in cases, bundles, threads etc. suitable for Rail/Road/Air/Sea transp ort. All exposed services/connections, protrusions shall be properly protected. All unexposed parts sh all be packed with due care and the packages should bear the words "HANDLE WITH CARE". The pack ing of the goods to be transported by Rail/Road/Airs/Sea shall be as per the conditions laid down by th e appropriate authorities and the vendor shall obtain clean railway/goods receipts without any qualifyi ng remarks. All packages and unpacked materials shall be marked on at least 2 (Two) places indicatin g the name of the purchaser/consignee, PO No., Gross and Net Weight and Dimensions with indelible paints in English. In case of bundles, metallic plates marked with the above details shall be tagged. All goods should be dispatched as per the relevant terms of the PO. In case of any mode of transport a s to be resorted to other than that mentioned in the PO, the same should be done only after obtaining prior approval in writing from the purchaser. All movements sanction, loading permissions etc. from R ailway or other authorities shall be obtained by the vendor. The vendor shall communicate the releva nt dispatch particulars immediately on dispatch by telex/telegram/fax to the consignee as specified in the PO.
