1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of guality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting

bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.

- 17) SECURITY DEPOSIT-CUM-PERFORMANCE GUARANTEE: Within Fourteen (14) days from the date of issuance of Contract/Work Order/Purchase order, the succe ssful Bidder shall furnish performance security for satisfactory execution of the or der for an amount equivalent to of <u>Three (3) Percent</u> of the value of the tot al Letter of Award (LOA)/ Work Order (WO)/Purchase Order/Contract value in the form of account payee Demand Draft/ Bank Guarantee issued/ confirmed from any of the Nationalised / Scheduled Bank as per the list provided in A nnexure-1 or updated list issued by RBI, safeguarding DVC's interest in all respects.

If the Contractor/Service Provider/Saler fails to submit the performance security within 30 days of the date of issuance of LOA/PO/Work Order, DVC without prejudice to any other rights or remedies it may possess under the Contract, may forfeit the bid security (wherever applicable) and shall short close th e Contract and retender and in this re-tender such defaulting Bidder will not be allowed to participate.

In case of Performance Security in form of Bank Guarantee:

 - a) After the expiry of the specified date of delivery / completion period, if the Co ntractor fails to deliver the materials/ complete the work a notice will be give n to the Contractor for delivering the material/ complete the work immediatel y.
 - b) If the Contractor fails to deliver the material/complete the work, a final risk a nd cost notice will be serve d to the Contractor by registered post with A/D, cl early indicating that if he fails to deliver the materials/ complete the work wit hin 7 days of the receipt of the letter, the same shall be outsourced from othe r source s at the risk and cost of the Contractor.
 - c) The existing order has to be closed and action will be initiated by the Employ er for procurement / completion of work & services of the balance items/ porti on. While taking such action the defaulting Contractor may be given an oppor tunity against fresh enquiry/limited tender.
 - d) If it is found that price has come on the higher side then the difference betwe en the original price and the new price will be recovered from the Contractor.
 - e) For the purpose of recovery of the amount, unpaid amount / security deposit by the way of BG as provided by the Contractor will be adjusted first. If there i s any balance left to be recovered, the Contractor should be informed to depo sit the money at the earliest.

- 20) **TERMINATION CLAUSE:** Termination of contract will be applicable as per Clau se No. 17 read with clause sl. No. 24 of OPTIONAL TERMS & CONDITIONS OF CO NTRACT of GCC. GCC-2022 is available in DVC website.
- 21) **SETTLEMENT OF DISPUTES & ARBITRATION:** Any dispute(s) or difference(s) arising out of this NIT & subsequent contract shall, to the extent possible, be s ettled amicably between DVC and the Power Trader.

In the event of any dispute or difference whatsoever arising under the NIT & sub sequent contract or in connection therewith including any question relating to e xistence, meaning and interpretation of the contract or any alleged breach there of, the same shall be referred to the Chairman of Damodar Valley Corporation, K olkata-54 or to a person nominated by him for arbitration. The Arbitration shall b e conducted in accordance with the provisions of arbitration and conciliation law 1996 or latest and the decision/ judgment of Arbitrator/Arbitrators shall be final and binding on both DVC and the contractor.

However, in case the Contractor will be a Central Public Sector Enterprise/ Govt. Department, the dispute arising between DVC and the Contractor shall be settle d through Permanent Arbitration Machinery (PAM) of the Department of Public E nterprise, Govt. of India as per prevailing rules.
