Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. - ii) 20% payment will be released within ten (10) days of issue of con signee receipt-cum-acceptance certificate (CRAC) and Installation, Commissioning and Testing (ICT) portion bills as certified by RCF representatives. However, if installation & commissioning is getting delayed by 180 days from the date of final supply and for the reasons not attributed to supplier, the balance 20% payment of supply portion shall be release d immediately against submission/confirmation of BG for equal amount and with validity of 20 months from the date of last supply.
- B) For Installation, Commissioning and Testing (ICT) support portion: 100% payment will be released within ten (10) days of issue of consignee receipt-cum-acceptance certificate (CRAC).

B. Disputes and Arbitration Clause:

a. Arbitration in case of Domestic vendor

In case of any dispute, difference, or question which may at any time arise between the parties hereto or a ny person claiming under them, touching or arising out of or in respect of this agreement or the subject m atter thereof shall be referred to the arbitration. Both the parties shall appoint the sole arbitrator with mut ual agreement in line with the Arbitration and Conciliation Act, 1996. The provisions of the Arbitration and Conciliation Act, 1996 and as amended from time to time shall apply to the proceedings conducted under t he arbitration. In case the party (parties) fail to appoint the sole arbitrator within 30 days from the date of r equest, the requesting party may approach the Court of Competent jurisdiction to appoint an Arbitrator.
