If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempte the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subse Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to gas a Class 1 local supplier is denoted in the bid document. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated o through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Or 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notific issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Po for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligi any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buye margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to r L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. - 5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similic Category Products for 10% of bid quantity, in at least one of the last three Financial years before the bid opening dain any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantitic any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. case of bunch bids, the category related to primary product having highest bid value should meet this criterion.
- 6. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher in value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conduct amongst L-1 to L-4).
