# 6) Payment Terms:

**Main Equipment, OBS & Documentation**: On receipt of Invoice, 100 % of Payment shall be made within 10 days from generation of Consignee Receipt & Acceptance Certificate(CRAC) of material and as reduced by any dedictibles and / or the amount leviable towards liquidated damages, if any plus 100% taxes, duties etc. as applicable.
