If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. (i.) Bidder must have successfully completed supply of "Similar Item". Bidder must have all necessary machining & fabrication facilities for manufacturing labyrinth seals on their own. Bidder must submit documentary evidence detailing the machining and fabrication facilities at their workshop for machining of similar items such as labyrinth seals. For the same bidder must submit an undertaking letter on their letter head detailing the above mentioned technical facilities of their workshop.

(ii.) Bidder shall provide the following documents along with technical bid

a) Details of past supplies of same/similar items of tender, successfully delivered in recent past 7 years (ending on last date of previous month of date of issue of NIT i.e. 30.09.2024) to Fertilizers industries; preferably PSUs.

Definition of Similar Item:

Similar Item means supply of labyrinth seals for blowers / compressors of MOC SS304 or higher grade.

b) Party to submit detail of One number of Purchase Order(s)/ work order(s) copies for past supplies of same/ similar item in line with serial number #ii above; successfully delivered in recent past 7 years (ending on last date of previous month of date of issue of NIT i.e. 30.09.2024) to any Fertilizers, Refineries, Petro chemical, power plant, pharmaceutical industries or continuous chemical process industries; preferably PSUs.

(iii.) The details & documents as per above (i) & (ii) shall be provided along with technical bid for NFL review & technical evaluation of bid. Bids without these details are liable for technical rejection / disqualification

B. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

C. Provisions of revised "Public Procurement" (Preference to Make in India) order 2017 notified vide order no. P- 45021/2/2017-PP (BE-II) dated 16/09/2020 of Ministry of Commerce and Industry, Department of Industrial Policy and Promotion (DIPP) shall be applicable.
