(b) The firm will be considered to be in breach of the procurement contract, in case physical damage, loss of information or infringements related to copyright and Intellectual Property Right (IPRs) are caused due to activation of any such malicious code in embedded software.

#### 20. **Generic**

**Non return of Hard Disk:** As per Buyer organization's Security Policy, Faulty Hard Disk of Servers/Desktop Computers/ Laptops etc. will not be returned back to the OEM/supplier against warranty replacement.

#### 21. **Warranty**

Warranty period of the supplied products shall be 3 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

#### 22. **Warranty**

Successful bidder will have to ensure that adequate number of dedicated technical service personals / engineers are designated / deployed for attending to the Service Request in a time bound manner and for ensuring Timely Servicing / rectification of defects during warranty period, as per Service level agreement indicated in the relevant clause of the bid.

#### 23. **Warranty**

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 10 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imburse the cost of such service / rectification to the Buyer.

#### 24. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. Bidders are advised to study all technical and commercial aspects, instructions, forms, terms and specifications carefully in the bid document. Failure to furnish all information required in the Bid Document or submission of a bid not substantially responsive to the Bid document in every respect will be at the bidder's risk and may result in the rejection of the bid.
2. Buyer reserves the right to reject any or all bids without assigning any reason whatsoever.
3. All damaged or unapproved goods shall be returned at the bidder risk and cost and the incidental expenditure thereupon shall be recovered from the concerned party.

4. The responsibility of the Bidder under the contract will be to supply quality products.
5. The responsibility of the Bidder is to supply brand new and standard products without any damage. The Bidder shall be responsible for any delay in supply.
6. The purchaser has full rights to place contract only on availability of funds after Bidder declared L1.
7. CA Certificate showing the last three financial years turnover of Bidder must be attached.
8. Seller will provide 36 months onsite warranty. In case of defect in the product, technicians/ representatives of seller must visit and inspect the product within 07 days of intimation of such defect by buyer and take action to rectify the defects. In case no representative/ technician of seller visit & inspect the defect ed product in that case decision of Buyer will be final and seller has to repair the defect and bear all costs of such repair without any representation by seller thereafter.
9. Bidders shall upload detailed technical specification wise compliance of technical specifications/QRs in following format :-
