#### 1. SCOPE OF WORK:

- Ø The scope of work includes providing of pest control services as per specifications against Gene ral Pest/Insect Control, Snake Control, Snake Control, Bee Management and rodent control of the entire area under BOQ using permitted chemicals equipment's, technology for maximum c urative and preventive protection

#### 4. Arbitration

In the event of any question, dispute or difference arising out of or in connection with this work, whet her during the progress of the work after its completion, abandonment or breach of contract, the sam e shall be referred for arbitration. The arbitration shall be conducted by a sole arbitrator. The sole Arb itrator shall be chosen from a panel of empanelled Arbitrators maintained by POWERGRID. The same shall comprise of retired Judges and retired Senior executives of PSUs other than POWERGRID. If the p arties fail- to appoint sole arbitrator within sixty (60) days after receipt of a notice from the other part y invoking Arbitration, the appointment of sole arbitrator shall be done by Courts as per the provision s of Indian Arbitration and Conciliation Act, 1996 or any statutory modification thereof. The cost of arb itral proceedings inter-alia including the Arbitrators' fee, logistics and any other charges shall be equ ally shared by both parties. In case of Sole Arbitrator, the fees to be paid to the sole Arbitrator shall be as per the terms of empanelment in POWERGRID. However, the expenses incurred by each party in connection with the preparation, presentation, etc. of its proceedings shall be borne by each party its elf. The decision of the sole arbitrator shall be final and binding upon the parties. In the event of any of the sole arbitrator dying, neglecting, resigning or being unable to act for any reason, it will be lawful for the parties to nominate another sole arbitrator in place of the outgoing arbitrator.

During settlement of disputes and arbitration proceedings, both parties shall be obliged to carry out the ir respective obligations under the Contract.

#### 5. TERMS OF PAYMENT

Payments shall be released by **F&A Dept., POWERGRID, PPPFC Dept., Bangalore/ Nagpur** on submis sion of Running/Interim Bill for the completed work. Bills along with all details of measurement sheets shall be submitted for release of payment through the Engineer-in-charge or his authorised representative.

Payment shall be released by F&A, Nagpur/Bangalore within 15 days of submission of bill with all relevant documents on quarterly basis

- 6. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in t he Bid document, ATC and Corrigendum if any.
- 7. Bidder shall submit the following documents along with their bid for Vendor Code Creation:

nts related to/identified as above submitted by the Bidders as per the provisions of the bidding Documents, the Employer may give the bidders not more than 03 working days' notice to rectify/furnish such documents, failing which the bid/prop osal is liable to be rejected. The request for clarification and the response shall be in writing, and no change in the price or substance of the proposal shall be sou ght, offered or permitted. Further, Successful bidder shall have to submit the ori ginal documents pertaining to forms mentioned at (c), (d) and buyer specific Inte grity pact at the buyers at address mentioned below before award of contract.

- 12. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consigne e only.
- 13. In case of default, the bids received/submitted/ uploaded by you shall be considered non respon sive/not eligible for a period of 1 (One) year reckoned from the date of issuance of the termination lette r by POWERGRID.
