1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- Copy of PAN Card.
- Copy of GSTIN.
- Copy of Cancelled Cheque.
- Copy of EFT Mandate duly certified by Bank.

3. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

Bidders Participation Criteria

NSPCL , a joint venture of NTPC Ltd. and Steel Authority of India Ltd. referred to herein as 'the Employer', intends to engage an agency for supply of Goods and related Services as per specifications, Scope of Work as detailed in the Bidding documents.

The items being procured in this BID are spares for the existing equipment installed by M/s.EDDY CURRENT CONTROLS (INDIA) in the Employer Plants. Hence, the BID submitted by the OEM-M/s. EDDY CURRENT CONTROLS (INDIA)/ their Channel Partner & OES-M/s.BHEL/ their Channel Partner only will be accepted and any other BIDs from the vendors other than OEM & OES/ their Channel Partner will be rejected.

Dealer must upload the Bid specific authorization letter along with their bid documents, failing which bid shall not be accepted.

The Employer reserves the right to accept or reject any Bid, and to annul the bidding process and reject all Bids at any time prior to Contract award, without thereby incurring any liability to the affected Bidder(s) or any obligation to inform the affected Bidder(s) of the grounds for the Employer's action.

Risk Purchase:- In the event of Suppliers failure to supply the material of acceptable quality in scheduled delivery period, NSPCL reserves the right to procure the materials from any other source at the Suppliers risk and cost and the difference in cost shall be borne by the Supplier. Further, NSPCL shall retain the right of forfeiture of CPG and or any other action as deemed fit".

Terms & Conditions:

1. Inspection clause: Visual Inspection shall be done at NSPCL Stores, upon receipt of material based on documents submitted by vendor.
2. Guarantee/ warranty Clause: All items should be guaranteed against poor workmanship/ manufacturing defect for a period of 18/12 months from the date of Supply at NSPCL Store/ use of material, whichever is earlier.
3. Fitment Guarantee: Applicable
4. Documents required with Bid for Bid evaluation: Vendors are requested to submit Techno-commercial offer along with endorsed "Tender document and SPC". Motors GA Drawing with sealed and signed copy to be submitted by Vendor along with their offer.
5. Documents required along with material Supply: Approved Drawing
 - a. Guarantee/ warranty certificate.
 - b. Fitment/Interchangeability Certificate.
 - c. Vendor has to submit factory routine test certificate at the time of supply.
6. Drawing and QP Approval: Applicable :Drawing Approval Required
7. Payment Terms: 100% payment within 30 days after receipt and acceptance of the material at NSPCL Site Stores.
8. Delivery period and Schedule: Delivery to be completed within 04 to 06 months from award .

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
