1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

1. **Nature of contract :** This BoQ based bidding is a **"Ann ual Rate contract for supply of Crockery items"** and the contract will be valid for one year from the date of contract order. The qua

ntity mentioned in the BoQ is for the entire year and not one-time supply. The supplier has to supply the material as and when demande d by us throughout the entire contract period of one year within the total financial limit of the contract.

2. **Quantity:-** The quantity of the items to be supplied is of te ntative nature and the actual quantity of individual items to be sup plied shall be based on requirement basis (unlimited/Nil quantity) b ut the party has to supply any of the items within the financial limit as indicated in their Purchase order value. The quantity may incre ase or decrease from the tentative quantity but restricted to total fi nancial limit. The party has to quote rates accordingly for individual items mentioned in the BoQ.

3. <u>Rates:</u> As this tender is not an Item rate contract, total consolidated amount of the rates quoted for individual items of all items shall be considered for L1 agency.
