The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

Offers from sub dealers will not be consider ed. Participating traders/agents must provide authorization letter issued by the OE M. Authorization letter s hould preferably be tender specific. In case of general authorization letter, it must clearly indicate the valid ity period/expiry date. Offers with general authorization letter sile nt on validity period/expiry date will not be considered for placement of order and that offer is liab le to be ignored. Bidders must submit authorizat ion letter along with their offer failing which the of fer is liable to be ignored.
- 3. Bidders should sign and upload the ATC specification showing that they adhere to the specificati on atta ched. Any offer without signed ATC will not be considered.
- 4. Bidders catalogue value should match with the ATC parameters otherwise offer will be passed o ver.
