- 1. Transportation: Shall be arranged by Vendor upto place of delivery. Transportation charge s shall be included in the quoted price & shall remain firm for total supply.

Packing & Forwarding: Price should be quoted inclusive of all Packing & Forwarding char ges. Additional charges, if any shall not be entertained at later stage. 2.8 <u>Payment Terms</u>:

- Payment of 90% of basic cost towards supply + 100% taxes+ 100% of Transportation, pack ing & forwarding and all other charges will be made within 90 days (45 days for MSE vendors & 60 days for Medium vendors) after submission of all documents as per Cl.No.2.0.c above.
- Payment of Balance 10% of respective basic value shall be made against submission of PBG (Performance Bank Guarantee) of equal amount (10% of the basic order value) from a nation alized bank valid for warrantee period as per Cl. No. 2.12 from the date of supply. In any cas e if vendor do not furnish the PBG for any reason, balance 10% of basic value shall be paid af ter completion of warrantee Period.

- **2.9 Taxes & Duties:** The quoted price shall be as per prevailing GST rate as may be applicable on date of submission of offer. However, if any new taxes & duties are introduced or any variation occurred in existing rate of GST subsequent to bid submission and during the currency of the execution of the order including its extension if any, the same shall be reimbursed at actual against documentary evidence to be submitted by the vendor. In case the delivery schedule is extended for the reasons attributable to the Vendor, no such variation shall be admissible.

Successful vendor has to file their GST return by the statutory date. 2.12 Warranty: 12 months from the date of supply

- **2.13 Interpretation of contract:** In case of two or more than two interpretations or differen ces in any of the technical specification or terms and conditions of the contract then the interpretation which is in favor of BHEL shall be final and binding.
- **2.14 Online Demonstration**: Online demonstration if requested by BHEL shall be in vendor sc ope. No extra Charges for the same shall be paid. The online demonstration shall be valid till completion of warrantee period.
- **2.15 Force Majeure:** The supplier shall not be considered in default if delay occurs due to cau ses beyond their control such as Acts of God, Natural Calamities, Frost, Fire, flood, Civil War, Civil Commotion, Riot, Government Restrictions.

Only those causes that have duration of more than seven days shall be considered cause of f orce majeure. Notification to this effect duly certifies by local chamber of commerce/statutor y authorities with supporting documents shall be given by the supplier to BHEL by registered letter/courier service without loss of time.

In the event of delay due to such causes the delivery schedule shall be extended for a length of time equal to the period of Force Majeure or at the option of BHEL the order may be cancel led. Such cancellation would be without any liability whatsoever on the part of BHEL.

In the event of such cancellation the supplier shall refund any amount advanced or paid to the supplier by BHEL and deliver back any material issued to him by BHEL and release facilities, if any provided by BHEL.

2.16 Defective Material replacement: Supplier shall replace defective material free of cost (inclusive of all testing, inspection, TPI, service charges etc.) upto delivery site within two m onths from defect notification date.

- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchas Order on the Seller.
