4.2 "BID SECURITY" also known as Earnest Money Deposit (EMD)

01. Officer- In Charge: DM / Manager /Sr Manager - CMM CMM, KGS 1-4, Plant Site NPCIL Kaiga Generating Station Dist-Uttar Kannada 581400 Intimation regarding supply on as and when basis will be given by Officer-in-Charge or his authoriz ed official. Seller shall contact Officer-in-Charge or his authorized official for collection and delivery of Tonners,

2.Delivery completion Date :

One year from the date of contract or till the completion of supply of ordered quantity whichever i s earlier. However if required the delivery completion date can be extended based on mutual cons ent .

3. Evaluation of Offer :

Evaluation shall be carried out on total summary price of all the tendered items . Bidder is required to quote for all the items otherwise their offer for part items shall not be considered for evaluation

4 Collection of Empty Tonner :

The seller has to collect the empty cylinders within 07 days from the date of intimation from office r in charge or his authorized official supplier

5. Filled Tonner should be delivered with in 10 days (NPCIL's Cylinders) from the date of intimatio n. However, in case of Emergency requirements, supplies shall be arranged to reach Kaiga site wit hin 3-4 days of instruction to supply.

6. Quantity Stipulation:

One years consumption of KGS would be approximately as mentioned in indent for supply/ service s. However it may please be noted that no guarantee can be given for procurement up to the ceili ng limit indicated above, as the requirements will be drawn on 'as and when required basis during the validity of contract period'.

7. Repair/Replacement of Spares/Servicing/Testing & Purging Charges:

For item No. 2 to 6, seller shall bring out the details of repair/replacement of spares/servicing inclu ding purging requirement of NPCIL's Tonner/s and upon written confirmation from Officer In charg e or his authorized official, such repair/replacement/servicing etc., shall be carried out at the rates specified in the contract.

The seller shall comply with the following: a. Whenever purging, testing etc carried out, relevant certificates shall be handed over along with the NPCIL's Tonner/s.

b. Defective Tonner caps/ valves to be returned to NPCIL, Kaiga.

c. Whenever spares/accessories are replaced, worn out spares shall be handed over along with sup ply to Manager(Materials) or his authorized official

d. Painting shall be carried after Hydro testing of respective Tonner. Apart from same, any request for painting of Tonners shall be executed by seller and respective invoices shall be handed over al ong with supply to Manager(Materials) or his authorized official.

e. Test certificate pertaining to Liquid Chlorine supply clearly showing the compliance of all techni cal required parameters, shall accompany during each batch of supply.

Reimbursement of Repair/replacement of spares/service charges etc. will be subject to certificatio n by Officer -In -Charge or his authorized official.

Whenever claim of above services are submitted. The details of NPCIL's Tonner nos, nature of wor k carried out, Certificate of Seller with the name of their person/persons who carried out work shal I accompany the claim.

8. Insurance Policy:

The Seller shall submit Insurance Policy which shall be valid till the contractual/actual date or till th e execution of the contract and shall cover "Any loss or damage to the NPCIL's material due to fire , riot, burglary, strike, theft, and any damages arising out of external sources such as damages du e to the materials falling on NPCIL's materials" of value in Rs 4,50,000/- towards Free Issue Materi al i.e. for maximum of 9 no's NPCIL owned Empty Tonners to be given for refilling at a time.

9. Indemnity Bond:

The Seller shall submit Indemnity Bond which shall be valid till the contractual/actual date or till th e execution of the contract of value in Rs. 4,50,000/- towards Free Issue Material i.e. for maximum of 9 no's Npcil owned Empty Tonners to be given for refilling at a time.

10. Minimum 07 and maximum 09 nos npcil owned tonner shall be delivered at a time for refilling

11. Loading, Handling and Unloading of Cylinders:

a) Loading and Handling of Filled Tonner and unloading of Empty tonner at Supplier's work/premis es shall be in 'Supplier's scope'

b) Loading and Handling of Empty Tonners and unloading of Filled tonner at Kaiga Generating Stat ion Site shall be in NPCIL's scope. However, tonner handling items like slings etc. duly load tested to be provided along with filled tonners for unloading .

12. Relevant Government rules shall be followed by the seller for supply, refilling and delivery of Li quid chlorine , hydro testing , painting and other works related to the contract .

13. Quoted rate shall be firm during the currency of the contract .

14. Quantity variance of + 25% shall be acceptable based on confirmation and acceptance of NPCI L KGS .

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
