1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier

as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. **2.** Authorised distributor certificate from OEM is mandatory (Applicable for Non-OEMs). Vendor will be technically disqualified if the above certificate is not submitted. Suppliers are requested to submit the offers for enqui red parts as per MPN (Manufacturer Part Number) only. Preference will be given to quotes received as per enquired MPN only. Offers h aving Alternate parts (attach Technical Data-sheet along with quot e) are liable to be rejected.

## 3. Specifications:

**a)** Materials should be offered strictly conforming to BEL's specifica tions. The deviations in specifications, if any, should be clearly indicated by supplier in their quotation. The supplier should also in dicate Make / Type Number of the materials offered and catalogues , technical literature and samples, wherever necessary, should be f orwarded by the supplier.

**5.** In case of change of Bank A/C: The vendor should provide ca ncelled cheque in original or Bank mandate issued by the banker a nd Board Resolution issued by the Board of Directors / Partners Res olution authorising Bank change as applicable.

**6. Insurance:** The supplier shall be responsible and should cover t he Insurance for all transit risks of the materials to be supplied agai nst their quotations 'F.O.R Bangalore' and 'F.O.R. BEL's Factory unl ess therwise stated specifically by the supplier in their quotation. T he Insurance of materials against quotations "Ex-works / Ex-Godow n / F.O.R. dispatching station" will be arranged by BEL.

7. Penal Interest: If the payment terms involves grant of advance , then penal interest equivalent to 2% above the prevailing SBI PLR rate) on advance will be charged in cases where the supplier is una ble to execute the order for whatever reason resulting in cancellati on / short-closure of the order / delay in supplies. The delayed perio d will be calculated with reference to scheduled date of supplies / c ompletion of milestones as per the purchase order.

## 8. Clauses for Counterfeit Material Parts:

I) In case of counterfeit material parts supplied by vendor, no pay ment shall be made to vendor. In case of line rejection due to coun terfeit material parts; payment will be recovered/deducted from ve ndor.

**II)** Counterfeit material parts will not be returned back and it shall be destroyed as per standard operating procedure.

**III)** Necessary action to debar vendor from enquiry/blacklist shall b e initiated.

**9. Delivery Date:** The supplier must adhere to delivery date by w hich the materials will be dispatched by them from the date of rele

ase of contract. If supplier fail to deliver the stores or any consignm ent thereof within the period prescribed for such delivery, BEL shall be entitled at their option:

**a) Liquidated Damages:** To recover from the supplier agreed liquidated damages, (and not by way of penalty) of sum of 0.5% (2. 5% in case of purchase orders placed on time preference basis) of the value of any stores not supplied in time for each week of delay or part of a week with a ceiling of 10% (25% in case of purchase or ders placed on time preference basis), or

**b)**To purchase elsewhere, at the risk and cost of the supplier, the s tores not delivered, or

c) To cancel the Contract order.

In the event of action being taken under b) & c) the supplier s hall be liable for any loss which BEL may sustain but the suppl ier shall not be entitled to any gain on repurchase made again st default.

**10. Certificate of Conformance:** Supplier must provide COC (Ce rtificate of Conformance) as per purchase order without fail. Payme nt will be made only COC /Test Reports are provided with supplies.

**11. OEM Authorised Distributor Certificate :** Bidder has to sup port the quote with OEM Authorised Distributor Certificate preferab ly.

**12. Payment Terms:** As per GEM standard Terms & conditions.

## 13. Rejections:

I) In case of GR Rejection: To and Fro Freight charges including i nsurance charges, custom duty charges to be borne by supplier for replacement or re-export of the rejected item and Replacement/Re pair to be made within original Order delivery date. In case of No Replacement/Repair or Delayed Replacement/Repair action will be taken as per Point "a, b & c" under "clause delivery d ate" is applicable.

**II) In case of any rejections during warranty period:** supplier shall arrange to collect rejected material and arrange for delivery a t BEL after repair at free of cost.

(To and Fro Freight charges including insurance charges, c ustom duty charges to be borne by supplier for replacemen t or re-export of the rejected item).

Replacement/Repair to be made within 30 days from the date of R ejection intimation from BEL.

**14. Dispatch after Delivery Date:** Vendor has to take concurren ce from BEL to dispatch items after Contract order delivery date.

**15. Guidelines Of Environmental Management System:** Pleas e follow the guidelines of environmental management system (EMS : ISO 14001:2015) like prevention of pollution of air, water and land . Please follow environment statutory recycle and reuse guidelines to conserve natural resources. Kindly inculcate environmental awar eness among all your employees. Hazardous Materials and Chemic als: Supplier should provide the MSDS (material safety data sheet) along with each item.

**16. Packaging:** In case of plastic used as packing material, the ve ndor has to use more than 40 microns thickness plastic for packing

**17. PBG**: Supplier has to give **PBG** upto 10% of order value for a p eriod of warranty plus 3 months claim period from any nationalised bank. If supplier fails to submit the **PBG**, equivalent amount shall b e deposited as security deposit.

**18. Warranty:** 36 months from the date of acceptance at BEL.

## **19. Credit of GST Clause:**

(I) Basic invoice value will be released as per the terms of paymen t and GST amount will be released only after the same is reflected i n BEL GST Portal (GSTR2B) and taxes are paid by the supplier to th e government.

(II) Cost including interest and penalty incurred by BEL due to non-payment & non-reporting of taxes in the government portal, by the supplier, will be recovered from the supplier.

All the local vendors (Indian Vendors) are requested to Provide the ORDERING ADDRESS with proper vendor Code and applicable GST Number from where the materials will be dispatched. In case of ch ange in the Address/GST Number the payment/GST amount cannot be processed.

**20. Inspection:** Material on its arrival at BEL's factory / site will be inspected by BEL's Inspection Department and their decision in the matter will be considered final and Copy of Inspection Report will b e forwarded to the supplier in case of rejections. The rejected mate rials will be returned to the supplier for replacement and all charge s on same will have to be borne by the supplier. The pre-despatch i nspection can be made by BEL / nominated agency / certifying age ncy or by vendor himself if he is specifically authorized for self insp

ection. Payment of pre-despatch inspection charges will be as mut ually agreed.

**21.Certificate of origin:** Certificate of origin should be arranged by the vendor, in origin for the materials procured from south Asian countries namely Malaysia, Singapore, Thailand, Vietnam, Myanma r, Indonesia, Brunel Darussalam, Lao people's democratic republic, Cambodia and Philippines.

**22. Made in China:** Items of Chinese origin / manufactured in chin a are not acceptable.

**23.** BEL reserves the right to accept or reject any quotation or part of the quotation without assigning any reasons. BEL reserves the right of ordering part quantities without assigning reasons and the s upplier shall supply the ordered quantity at accepted rates.

BEL reserves the right to order / cancel the bid without pre intimati on.

**24. Integrity Pact:** Integrity Pact and Bank Guarantee: In case of quotation value exceeding 3 Crores in Indian rupees or equivalent value, the supplier will have to sign integrity pact at their own cost is required to sign the integrity Pact with BEL as per BEL purchase policy based on the intimation given by the Purchase department. Also the Supplier should agree to sign the integrity pact as and wh en changes are made in the purchase policy as intimated by purch ase department.
