Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. # III. ELIGIBILITY IN TERMS OF EXPERIENCE AND FINANCIAL CRITERIA

- 1. Work Experience As specified in the Tender / Tender Schedule. How ever, wherever the similar nature of work is specifically prescribed the Tender / Tender Schedule, the bidder should have satisfactorily in the last three previous financial years and the current financial year up to the date of opening of the tender, one similar single service contract for a minimum of 35% of advertised value of the bid.
  - **a.** Completed service contract includes on-going service contract subject to payment of bills amounting to at least 35% of the advertised value of the bid.

**b.** Similar service contract means any contract that is so specified by the competent authority.

Work experience certificate from private individual shall not be accepted. Ce rtificate from public listed company/private company/Trusts having annual tu rnover of Rs.500 crore and above subject to the same being issued from their Head office by a person of the company duly enclosing his authorization by the Management for issuing such credentials.

## **Notes:**

The bidder shall submit details of work executed by them in the prescribed form at wherever required along with bid for the Service contract to be considered for qualification of work experience criteria clearly indicating the nature/scope of contract, actual completion cost and actual date of completion for such contract. (as per GCC-2018)

2. Financial Standing: The Bidders will be qualified only if they have mini

mum financial capabilities as below —

a. T1- Financial Turnover: The bidder should have an aggregate financial Turnover not less than 1.5 times the advertised Bid value during the last three previous financial years and in the current financial year up to the date of opening of the tender. The audited bal ance sheets reflecting financial turnover certified by chartered accountant with his/her stamp, signature and membership number shall be considered.

**T2-Liquidity:** The bidder should have access to or has available li quid assets, lines of credit and other financial means to meet cash flow that is valued at 5% of the estimated bid value net of applican t's commitments for other contracts. The audited balance sheet an d/or banking reference certified by chartered accountant with her s tamp, signature and membership number shall be submitted by the bidder along with bid.

Banking reference should contain in clear terms the amount that bank will be in a position to lend for this work to the applicant/member of the Joint Ventur e/Consortium. In case the Net Current Assets (as seen from the Balance She ets) are negative, only the Banking references will be considered. Otherwise the aggregate of the Net Current Assets and submitted Banking references will be considered for working out the Liquidity.

The banking reference should be from a Scheduled Bank in India and it should not be more than 3 months old as on date of submission of bids.

In Case of JV firms overall liquidity of JV firm shall be assessed by arithmetic sum of liquidity of all members of JV. (as per GCC-2018)

- **3. Other Criteria:** Based on the nature of services required, type of and other such considerations, the competent authority may include any ot her criteria as it deems fit in the minimum eligibility criteria for the qualification of bidders. # **Employment/Partnership etc. of Retired Railway Employees**

Should a Bidder be a retired Manager of the Gazetted rank or any o ther Gazetted Officer working before her retirement, whether in the exe cutive or administrative capacity or whether holding a pensionable post or not, in any department of any of the railways owned and administere d by the President of India for the time being, or

- **(b)** Should a Bidder being partnership firm have as one of its partners a R etired Manager or retired Gazetted Officer as aforesaid, or
- (c) Should a Bidder being an incorporated company have any such retired Manager or retired officer as one of its Directors or
- Should a Bidder have in her employment any retired Manager or retired Gazetted Officer as aforesaid, then the full information as to the date of retirement of such Manager or Gazetted Officer from the said service and in case where such Manager or Officer had not retired from Government service at least one year prior to the date of submission of the Bid as to whether permission for taking such contract, or if the contractor be a partnership firm or an incorporated company, to become a partner or Director as the case may be, or to take the employment under the contractor, has been obtained by the Bidder or the Manager or Officer, as the case may be from the President of India or any officer, duly authorized by her in this behalf, shall be clearly stated in writing at the time of submitting the Bid.

Bids without the information above referred to or a statement to the effect th at no such retired Manager or retired Gazetted Officer is so associated with the Bidder, as the case may be, shall be rejected. (as per GCC-2018)

- (e) Should a Bidder of contractor being an individual on the list of approved Contractors, have a relative(s) of in the case of partne rship firm or company of one or more of her shareholder(s) or a relative(s) of the shareholder(s) employed in gazette capacity in any department of Indian Railway, the authority inviting bids sh all be informed of the fact at the time of submission of Bid, failing which the bid may be disqualified/rejected or if such fact subsequently comes to light, the contract may be rescinded in accordance with the provision in Clause 7.4 of the General Conditions of Contract.
- (f) If the bidder or any of its constituents has been levied with a penalty for violation of labour laws for three times in the last two years (from the date of opening of tender) by the appropriate enforcing agency like the L abour Commissioner etc. The contractor shall be disqualified from partici pating in the bidding for services in a Railway division,
  - (i) If any previous contract of the bidder or any of its constituents had been terminated under clause 7.4 in that Railway division, with in the previous 2 years from date of submission of bids.
  - (ii) In that Railway division, the bidder or any of its constituents has bee n imposed a penalty equivalent to the maximum penalty that can be imposed under a previous contract. Such a figure being specified, with in the previous 2 years from date of submission of bids. (Period of 2 years shall be reckoned from the date on which the total accrued amount of penalties has reached the maximum penalty that can be imposed under the contract, as specified by the Competent Authority)

The declaration to this effect shall be furnished by the contractor as a part of his bid document. A for mat in this regard shall be made a part of the tender document. In case this declaration is found t o be false, process for 'banning of business' against the bidder/contractor shall be initiated as per extent rules. (as per GCC-2018)

Note: The bidder should be required to attach attested copies of the relevant docum ents in support of their credentials for being considered during technical evaluation. As per the marking assigned in the table above, each bidder shall be assigned score for technical bid. As per clause 1.2.2.2 of standard bid document (Issued by R ailway board), Bidder's who's score of technical bid shall be 60 or above shall be qualified for consideration of their financial bids. "The Tenderers shall submit a copy of certificate stating that all their statements/documents submitt ed along with bid are true and factual. Standard format of Certificate to be submitted by the bidder is enclosed as **Annexure-C. Non submission of above certificate by the bidder shall result in summarily rejection of his/their bid.** It shall be mandatorily incumbent upon the tenderer to ide ntify state and submit the supporting documents duly self-attested by which they/he is qualifying the Qualifying criteria mentioned in the Tender document.

It will not be obligatory on the part of Tender Committee to scrutinize beyond the submitted docume nt of tenderer as far as his qualification for the tender is concerned."

With the submission of the certificate as mentioned above, the practice of verification of tenderers doc uments by the Railways may be dispensed with.

- a) The Railway reserves the right to verify all statements, information and documents submitted by the bidder in his tender offer, and the bidder shall, when so required by the Railway, make available all s uch information, evidence and documents as may be necessary for such verification. Any such verification or lack of such verification, by the Railway shall not relieve the bidder of its obligations or liabilities hereunder nor will affect any rights of the Railways there under.
- b) In case of any wrong information submitted by Tenderer, the contract shall be terminated, Earnest M oney Deposit (EMD), Performance Guarantee (PG) and Security Depot (SD) of contract forfeited and agency barred for doing business on entire Indian Railways for 5 (Five ) years.
- c) With such a system of self-certification of credentials, tender finalization should also be speeded up.
