1. Purchase preference to Micro and Small Enterprises (MSEs) from the State of Bid Inviting Authority: Purchase preference will be given to MSEs as Micro and Small Enterprises from the State of Bid inviting Authority. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of

purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 100 % of total quantity as defined/ decided in relevant policy.

- 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 3. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 1) Terms and conditions for participation in the tender.

- i) Tenderer should produce valid PAN issued by IT Department, Govt. Of India, valid 15-digit Goods and Services taxpa yer Identification Number (GSTIN) under GST Act, 2017, ITR for last 2years, latest Professional Tax returns copy and certificate. In case of manufacturing unit Factory License is to be submitted. Signed copy of ATC is to be manda torily uploaded as a testimony of acceptance of all terms & conditions put up in the Bid document.
- ii) Trade license will be mandatory for those whose unit is located within the jurisdiction of KMC.
- iii) Offered products should be ISI marked.
- iv) This cable is going to be used in Deshbandhu Park Solar power generation Project under KMC.
- v) The bidder has to provide a warranty of minimum 2 years from the date of supply.

vi)

a) Intending tenderers should produce credentials of a similar nature of completed work of the minim um value of 40% (Forty percent) of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice;

In case the bidder suffers from any blacklisting/ debarment by any Govt. /Govt. Undertaking/Statutory Bodies established by an act of central or state government/ Municipal bodies in any supply of stores items at the time of submission of bid, he will not be eliqible to participate in the tender.

- 3) The eligibility of a bidder will be ascertained on the basis of the document(s) in support of the eligibility criteria as mentioned in Clause 1 above. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper is incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that appli cation will be rejected without any prejudice. In that case EMD submitted by the bidder will be forfeited and the bidder may be debarred from participating in any tender by KMC in future.
- 4) Not more than one tender should be submitted by a tenderer in his own name or in the name of partnership concern for a partnership company, private company or private limited company.
- 5) Earnest Money: Successful bidder has to provide a security deposit in the form of e-PBG of 5% of the order value as per GeM format
- 6)The price preference will be governed by the notification vide no. 10500-F of West Bengal Financial Rule (WBFR) issued by Go vt. of West Bengal Finance Department, Audit Branch.
- 7)Quoted price should include statutory payments (like GST or any other Govt. taxes if applicable). Escalation of Price on any ground and subsequent cost overrun shall not be entertained under any circumstances. Rates should be quoted accordingly.
- 8) Whenever the contracts are rescinded the security deposits shall be forfeited.
- 9) Offer for each item will be considered separately and the lowest bidder for each and individual item will be considered for a warding the contract.
