#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

#### 3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### 4. Generic

**Manufacturer Authorization:** Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

#### **5.1 QUALIFICATION CRITERIA:**

The supplier shall be either OEM M/s. Woodward governor or any of its genuine authorized dealer or chann el business partner.

For inhouse testing, the Sellers will provide necessary facilities free of cost. Seller shall notify th e Buyer through e-mail about readiness of goods for pre-dispatch inspection and Buyer will notify the Selle r about the Authorized Representative/ Nominated External Inspection Agency and the date for testing. The e goods would be dispatched to consignee only after clearance in pre-dispatch inspection. Consignee's right of rejection as per GTC in respect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having previously been inspected, tested and passed by Buyer/ Consignee or its Nominated External Inspection Agency prior to the goods' shipment. When there is requirement of su bmission the advance sample, the seller shall inform the buyer promptly through emails about the date of submission of sample to the buyer nominated Inspection agency. Test Certificates and Guarantee Certificates if required by the Inspector shall be obtained and furnished to him free of cost by the Contractor and/or from the specified agency.

- 5.6 The documents not submitted along with the bid and clarifications sought during the evalu ation stage, but now being submitted during representation shall not be considered, for evalu ation.
- 5.7 The Seller shall submit Original invoice clearly marked for 'Bill to Paying authority' and 'Shipped to Consignee', Annexure F (copy enclosed in Buyer uploaded ATC document), Seller's Bank details, E-invoice if applicable to Seller based on his turnover, Test certificate (if applicable) etc to the Paying Authori ty directly, immediately after despatching material to the Consignee. As payment is to be released in a time bound manner, non-receipt of these documents in time may lead to rejection of supplies.
- 5.8 **Performance Security:** Successful bidder shall furnish e-PBG for 5% of the Contract value in the form of a Bank Guarantee within 15 days of placement of contract for the duration of 26 Months.
