1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

2. Rejection of bid / tender:

In case of any specific adverse report received against a tenderer/bidder/ seller by SAIL, in respect of capa bilities and / or performance of the tenderer/ bidder/ seller, the bid of such tenderer is liable to be rejected.

3. Responsibility for Performance of Contract:

a) The Seller shall be entirely responsible for the performance of the contract in all respects in accordance with the terms and conditions as specified in the Contract.

b) Wherever, the seller is an authorized reseller of the manufacturer, both the authorized reseller and the manufacturer will be jointly & severally responsible for the performance of the contract in all respects in a coordance with the terms and conditions as specified in the Contract.

5. Removal of Rejection:

11. Weighment:

13. Force Majeure:

The Notice of declaration of Force Majeure must be supported by the Certificate of relevant Railway / Port Authority/Chamber of Commerce/Government or Quasi Government body. If the said certificate is not avail able, the Affected Party must provide a certificate signed by the Affected Party's Company Secretary and o ne of the Directors on the Board of the Affected Company. In addition, the Affected Party shall also intimat e the cessation of such Force Majeure. 14. b) Buyer will be entitled to terminate the Agreement by giving prior notice of at least 2 months to the othe r party if the other party goes into voluntary liquidation or is ordered to be wound up or is declared bankru pt, insolvent etc., by a court of law and is unable to pay its debts as they become due, and in the event of such termination, all sums due under the Agreement to either party on the date of the notice shall be imm ediately payable upon demand.

c) Termination of the Agreement shall not affect obligations of either Party that may have accrued prior to the effective date of termination.

In particular, it is expressly understood and agreed that the Government of Indi a is not a party to the Contract and has no liabilities, obligations or rights hereunder. It is expressly underst ood and agreed that Buyer (SAIL) is an independent legal entity with power and authority to enter into con tracts solely in its own behalf under the applicable laws of India and general principles of contract law. The Seller expressly agrees, acknowledges and understands that Buyer is not an agent, representative or dele gate of the Government of India. It is further understood and agreed that the Government of India is not an d shall not be liable for any acts, omissions and commissions, breaches or other wrong arising out of the C ontract. Accordingly, the Seller hereby expressly waives, release and forgoes any and all actions or claims including cross claims, impleader or counter claims against the Government of India arising out of the Cont ract and covenants not to sue the Government of India in any manner, claim cause of action or take any a ction whatsoever arising out of or under the Contract.

22. Confidentiality:

All documents, drawings, samples, data, associated correspondence or other information furnished by or o n behalf of the Buyer to the Seller, in connection with the contract, whether such information has been fur nished before, during or following completion or termination of the contract, except what is in public domai n are confidential and shall remain the property of the Buyer and shall not, without the prior written conse nt of Buyer neither be divulged by the Seller to any third party, nor be used by him for any purpose other t han the design, procurement, or other services and work required for the performance of this Contract. If a dvised by the Buyer, all copies of all such information in original shall be returned on completion of the Sel ler's performance and obligations under this contract.

23. Code of Integrity:

A) By participation in this tender, Sellers, Bidders, Suppliers, Contractors, and Consultants are deemed to have declared that they shall observe the highest standard of ethics and shall not indulge in the following prohibited practices, either directly or indirectly, at any stage during the Tender Process or during the exec ution of resultant contracts:

1) "Corrupt practice" - making offer, solicitation or acceptance of a bribe, reward or gift or any material be nefit, in exchange for an unfair advantage in the Tender Process or to otherwise influence the Tender Process;

2) "Fraudulent practice" - any omission or misrepresentation that may mislead or attempt to mislead so th at financial or other benefits may be obtained or an obligation avoided. Such practices include a false decl aration or false information for participation in a tender process or to secure a contract or in the execution of the contract;

3) "Anti-competitive practice" - any collusion, bid-rigging or anti-competitive arrangement, or any other pr actice coming under the purview of the Competition Act, 2002, between two or more bidders, with or witho ut the knowledge of the Buyer, that may impair the transparency, fairness, and the progress of the Tender Process or to establish bid prices at artificial, non-competitive levels;

4) "Coercive practice" - harming or threatening to harm persons or their property to influence their particip ation in the Tender Process or affect the execution of a contract;

5) "Conflict of interest" -participation by a bidding firm or any of its affiliates who are either involved in the Consultancy Contract to which this procurement is linked; or if they are part of more than one bid in the pr ocurement; or if their personnel have a relationship or financial or business transactions with any official of Buyer who are directly or indirectly related to tender or execution process of contract; or improper use of i nformation obtained by the (prospective) bidder from the Buyer with an intent to gain unfair advantage in the Tender Process or for personal gain;

6) "Obstructive practice" - materially impede Buyer's investigation into allegations of one or more of the a

bove mentioned prohibited practices either by deliberately destroying, falsifying, altering; or by concealing of evidence material to the investigation; or by making false statements to investigators and/ or by coerciv e practices mentioned above, to prevent it from disclosing its knowledge of matters relevant to the investi gation or from pursuing the investigation; or by impeding the Buyer's rights of audit or access to information;

B) Obligation of Proactive Disclosure

1) Sellers, Bidders, suppliers, contractors, and consultants are obliged under this Code of Integrity to suomoto proactively declare any conflict of interest (coming under the definition mentioned above - pre-existi ng or as and as soon as these arise at any stage) in any Tender Process or execution of the contract. Failur e to do so shall amount to a violation of this code of integrity.

2) Seller/ Bidder must declare, whether asked or not in a bid-document, any previous transgressions of suc h code of integrity with any Procuring entity during the last three years or of being debarred by the any ot her Organization Failure to do so shall amount to a violation of this code of integrity.

3) Such declarations would not mean automatic dis-qualification for the bidder/ Seller making such declara tions. The declared conflict of interest shall be evaluated for taking mitigation steps, where possible. Simil arly voluntary reporting of previous transgressions of code of integrity elsewhere shall be evaluated barrin g cases of various grades of debarment; an alert may be kept on the bidder's/ Seller's actions in the tende r and subsequent contract.

C) Punitive Provisions:

Without prejudice to and in addition to the rights of the Company to other penal provisions as per the bid d ocuments or contract, if the Company comes to a conclusion that a Bidder/Seller, directly or through an ag ent, has violated this code of integrity in competing for the Contract or in executing a contract, the Compa ny may take appropriate measures including one or more of the following:

i) If his bids are under consideration in any procurement:

a) Forfeiture or encashment of bid security

b) Calling off of any pre-contract negotiations, and;

c) Rejection and exclusion of the bidder from the procurement process

ii) If a contract has already been awarded:

a) Cancellation of the relevant contract and recovery of compensation for loss incurred by the Company;

b) Forfeiture or encashment of any other security or bond relating to the procurement;

c) Recovery of payments including advance payments, if any, made by the Company along with interest th ereon at the prevailing rate;

iii) Provisions in addition to above:

a) Removal from the list of registered suppliers and banning/debarment of the bidder/ seller from participat ion in future procurements of the Company

b) In case of anti-competitive practices, information for further processing may be filed with the Competitio n Commission of India;

c) Initiation of suitable disciplinary or criminal proceedings against any individual or staff found responsible

24. Business responsibility and sustainability:

At SAIL, we deeply value the vital role that companies can play in safeguarding and promoting human rights in the long term. We recognize our responsibility to uphold the spirit of human rights, as outlined in exis ting international standards, such as the Universal Declaration and the Fundamental Human Rights Conven tions of the International Labour Organization.
