- 2. Warranty: All items supplied shall be covered under warranty against any manufacturing defects for a period of 12 (Twelve) months from the date of supply.
- 3.Payment terms: 100% payment to be made with in 30 days of supply of items at delivery site and submi ssion of relevant documents of payment. However, in case of site not ready (SNR) situation ,NTPC will rele ase 90% of the payment on delivery after waiting period of 14 days and balance 10% on final installation a nd acceptance of materials.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
