1. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

3.1 Qualification Criteria

Bidder shall be either OEM or Authorised Dealer of OEM. In case of Authorised dealer, Valid OEM Authorization Certificate shall be submitted by the bidder as a proof along with the bid.

3.2. "The documents not submitted along with the bid and clarifications sought during the evaluation stage, but now being submitted during Representation shall not be considered for evaluation".

3.3. The Seller shall submit Original Invoice clearly marked for 'Bill to - Paying authority' and 'Shipped to - Consignee', Annexure-F (copy enclosed under Clause No. 4 in Buyer uploaded ATC document of the bid), Seller's Bank details, E-invoice if applicable to Seller based on his turnover, Test certificate (if applicable) etc to the Paying Authority directly, immediately after despatching material to the Consignee. As payment is to be released in a time bound manner, non-receipt of these documents in time may lead to rejection of supplies."

3.4. Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. Relevant documentary evidence in this regard shall be uploaded along with the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1 + 15% of margin of purchase preference / price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% percentage of total QUANTITY. Benefits of Public Procurement Policy shall be given to all eligible MSEs as stated under Point no.3 of FAQ dt. 25/03/2022, irrespective of product categories and the category they are registered under viz. Manufacturing or Service.

3.5."BID SECURITY" also known as Earnest Money Deposit (EMD):

3.5.1. Bidders can also submit the EMD with Account Payee Demand Draft in favour of Accounts Officer NP CIL Kaiga payable at NPCC Kaiga Branch.

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy

to the Buyer within 5 days of Bid End date / Bid Opening date.

3.5.2. Bidders can also submit the EMD with Banker's Cheque in favour of Accounts Officer NPCIL Kaiga payable at NPCC Kaiga Branch.

Bidder has to upload scanned copy / proof of the BC along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

3.5.3. Bidders can submit EMD preferably through SBI Collect Facility. Steps to follow to avail this facility is detailed below:

3.5.3.1. Go to authenticate website of SBI online.

3.5.3.2. Go to SBI collect tab & click.

3.5.3.3. Go to PSU-Public Sector Undertaking tab & click

3.5.3.4. Type "Nuclear Power Corporation of India" in search bar.

3.5.3.5. Select "Karnataka" as State in filter option in State tab.

3.5.3.6. Select payment category for "EMD/ Performance Security"

3.5.3.7. Fill up the requisite details & follow the procedure of bank payment.

Note:- Bidders may contact SBI Customer Service Helplines, if any, required to complete the transaction.

3.5.4. Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C: "Accounts Officer NPCIL Kaiga". The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of EMD, the FDR will be released in the favour of the bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date.

3.6. Performance Security:

3.6.1. Successful bidder shall furnish e-PBG for 5% of the Contract value in the form of a Bank Guarantee within 15 days of placement of contract for the duration of 18 Months.

3.6.2. Performance security shall be in the form of Bank guarantee.

3.6.3. Alternative to Bank Guarantee, Insurance Surety Bond is also an acceptable form with respect to performance security..

13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
