defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. (1) **Work Experience** -The bidder should have satisfactorily completed in the last three previous financial years and the current financial year upto the date of opening of the tender, one similar single service contr act** for a minimum of 35% of advertised value of the bid. *Completed service contract includes ongoing s ervice contract subject to payment of bills amounting to at least 35% of the advertised value of the

bid.

** Definition of Similar single work : - "Hiring of Vehicle in -

- a. Any Government Department, or
- b. Any PSU, or
- c. Any public listed company."

Work experience certificate from private individual shall not be accepted. Certificate from public listed com pany/private company/Trusts having annual turnover of Rs 500 crore and above subject to the same being issued from their Head office by a person of the company duly enclosing his authorization by the Managem ent for issuing such credentials.

Notes: The bidder shall submit completion / performance certificate issued by competent authority along with bid for the service contracts to be considered for qualification of work experience criteria clearly indic ating the nature/scope of contract, total contract value, date of commencement, date of completion, detail s of extension and revised value, actual date of completion and total payment made against such contract s.

(2) **Financial Standing:** The Bidders will be qualified only if they have minimum financial capabilities as b elow -

a)-T1- Financial Turnover: The bidder should have an aggregate financial turnover not less than 1.5 times t he advertised Bid value during the last three previous financial years and in the current financial year upto the date of opening of the tender . The audited balance sheet reflecting financial turnover certified by char tered accountant with her stamp, signature and membership number shall be considered.

b)-T2-Liquidity: The bidder should have access to or has available liquid assets, lines of credit and other fin ancial means to meet cash flow that is valued at 5% of the estimated bid value net of applicant's commitm ents for other contracts. The audited balance sheet and/or banking reference certified by chartered accou ntant with her stamp, signature and membership number shall be submitted by the bidder along with bid.

Banking reference should contain in clear terms the amount that bank will be in a position to lend for this work to the applicant/member of the Joint Venture/Consortium. In case the Net Current Assets (as seen fro m the Balance Sheets) are negative, only the banking references will be considered. Otherwise the aggreg ate of the Net Current Assets and submitted Banking references will be considered for working out the Liqu idity.

The banking reference should be from a Scheduled Bank in India and it should not be more than 3 months old as on date of submission of bids.

Bids without latest audited balance sheet and latest complete list of works on hand as per annexure-IV sha II be **summarily rejected**.

Note: For tender with opening date between April to September, in case audited balance shee t of previous financial year is not available for calculating the financial turnover-of the-firm, C ertificate from Chartered Accountant issued on the basis of any other Government approved d ocument like GST Returns/VAT Statement will be applicable.

(3) - Self-Certificate: Please submit a certificate in the prescribed format as per Annexure-V fo r verification / confirmation of the documents submitted for compliance of eligibility / qualifyi ng criteria. Non-submission of the certificate, or submission of certificate either not properly f illed in, or in a format other than the prescribed format shall lead to summary rejection of you r offer.

(4) **Possession of Machine & Plant:** The contractor shall possess the vehicles which he proposed to use under this tender contract registered by competent authority in his name/company or firm's name/partner 's name or shall have a power of attorney / lease agreement of the vehicle in his name/company or firm's name/partner's name. Power of attorney / lease agreement if vehicle is not owned by the contractor and V ehicle Registration Certificate of the proposed vehicle to be used in the contract shall be submitted by the bidder along with declaration as per Annexure-VI, otherwise its offer shall be **summarily rejected**.

(5) **Minimum Workability of Rates:** Minimum workability of Rates shall be calculated for this tender as per below methodology and bids having rates below minimum workable rates shall be summarily rejected without technical evaluation of the offers.

(A) Minimum Wages: Minimum wages for contract duration for semi-skilled worker for B Area, considering 3 0 days per month including 13% EPF (with ceiling of Rs. 1950 per month), 3.25% ESIC (if basic wages are b elow Rs. 21,000 per month).

(B) Fuel Cost: Fuel cost for contract duration will be calculated for package KMs + Additional KMs consideri ng mileage of 20 KMs / Liter and lowest Diesel price between first day of the month of opening of the tende r and date of opening of the tender as provided in the URL https://www.goodreturns.in/diesel-price-in-jabal pur.html

(C) Vehicle Depreciation Cost: Depreciation cost for contract duration will be calculated considering 15% p er year depreciation for 03 years old vehicle having initial cost of Rs. 8,00,000.00 using Written Down Valu e Method.

(D) GST on (A), (B) and (C) @ 5%

(E) Minimum workable cost = (A) + (B) + (C) + (D)

Note: If there is any doubt or confusion regarding calculation of minimum workable rates, same may be cla rified by visiting this office during Monday to Friday, 9:30 to 18:00 hours.

(6) These Special conditions of contract (SCC/STC) (along with Specifications of work and other conditions as contained in this Tender Document) shall be read together with the terms and conditions incorporated i n this tender document and General Conditions of Contract for Service Contract (GCC) of Railway board. If any conflict between GeM GTC and tender document with GCC Service RB, then STC/STC with GCC Service RB will prevail. GCC for Service issued by Railway board will be applicable in this contract.

(7) Tenderer should upload the scan copy of all documents relating to Eligibility criteria along with their off er such as scanned copies of mandatory credentials Experience / completion certificates, Turn over certific ates and any other documents such as partnership deed, power of attorney, affidavit PAN, GSTIN, ESIC, EP F as applicable.

(8) It is responsibility of the tenderer that they ensure to see any corrigendum of the tender to check the c orrigendum on the website from time to time.

(9). Railway Administration reserves the right to change/ Alter/Cancel the tender without any notice.

(10). Declaration by bidder:

(10.1) I/We have carefully gone through the Scope work/specifications, special conditions etc. attached wit h the tender documents.

(10.2) I/ We have visited the works site and I / We am / are aware of the site conditions.

(11) **Performance Guarantee:** Performance guarantee at a rate of 5% of the contract value shall be dep osited by the successful bidder. The successful bidder shall have to submit a Performance Guarantee (PG)

valuing 5% of the contract value, within 30 (thirty) days from the date of issue of Letter of Acceptance (LO A). Extension of time for submission of PG beyond 30 (thirty) days and upto the date of submission of PG fr om the date of issue of LOA may be given by the Authority who is competent to sign the contract agreeme nt. However, a penal interest of 15% per annum shall be charged for the delay beyond 30 (thirty days, i.e. from 31st day after the date of issue of LOA. In case the contractor fails to submit the requisite PG after 60 days from the date of issue of LOA, a notice shall be served to the contractor to deposit the PG immediatel y however not exceeding 90 days from the date of issue of LOA). In case the contract shall be terminated duly forfeiti ng EMD and other dues, if any payable against that contract. The failed contractor shall be debarred from participating in retender for that work. In case 60th day is a bank holiday or office closure next working da y should be considered as the last day for submission of the PGs. Decision of Authority competent to sign t he Contract Agreement would be final in case of any dispute.

(B) Banker's Cheque in favor of Sr.DFM payable at JBP. Bidder has to upload scanned copy / proof of the B C along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Op ening date.

(C) Fixed Deposit Receipt made out or pledged in the name of A/C (Name of the Buyer). The bank should c ertify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of EMD, the FDR will be released in the favor of the bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
