2.6.1 Minimum Eligibility Criteria

2.6.1.1 Technical Criteria: The bidder should have satisfactorily completed* in the last three prev ious financial years and the current financial year up to the date of opening of the tender, one similar single service contract** for a minimum of 35% of advertised value of the bid.

*Completed service contract includes on-going service contract subject to payment of bills amounti ng to at least 35% of the advertised value of the bid.

** Similar service contract means

"Mechanized cleaning of coaches in any of the coaching depots of In dian Railways"

OR

Mechanized en-route cleaning of trains during their stoppage under the "Clean Train Station" scheme

OR

Providing "On Board Housekeeping Services on trains"

OR

Mechanized Cleaning services rendered in a) Airports or b) 3 star an

d Higher-grade hotels or c) Hospitals having minimum 100 beds or d) Govt./PSU office complexes. Or e) Public listed company/Private company/Trusts having annual turnover of Rs.500 crore and above.

OR

Mechanized Cleaning of Railway stations."

Work experience certificate from private individual shall not be accepted. Certificate from public listed company/private company/Trusts having ann ual turnover of Rs 500 crore and above subject to the same being issued from their Head office by a person of the company duly enclosing his authorization by the Management for issuing such credentials.

Notes:

The bidder shall submit details of work executed by them in the prescribed format along with bid for the service contracts to be considered for qualific ation of work experience criteria clearly indicating the nature/scope of cont ract, actual completion cost and actual date of completion for such contract.

- **2.6.1.2. Financial Standing:** The Bidders will be qualified only if they have minimum financial capabilities as below —
- **(A).** T1-Financial Turn Over: The bidder should have an aggregate finan cial turnover not less than 1.5 times the advertised Bid value during the last three previous financial years and in the current financial year up to the date of opening of the tender. The audited balance sheet reflecting financial turnover certified by chartered accountant with her stamp, signature and membership number shall be considered.

However, in case balance sheet of the previous year is yet to be a udited, the audited balance sheet of the fourth previous year shall be considered.

(B). Liquidity: The bidder should have access to or has available liquid as sets, lines of credit and other financial means to meet cash flow that is valued at 5% of the estimated bid value net of applicant's commitments for o ther contracts. (To be submitted as per Annexure-4).

The audited balance sheet and/or banking reference certified by chartered accountant with her stamp, signature and member ship number shall be submitted by the bidder along with the bid.

Banking reference should contain in clear terms the amount that bank will be in a position to lend for this work to the applicant /member of the Joint venture/consortium. In case the net current assets (as seen from the balan ce sheets) are negative only the banking references will be considered. Ot herwise aggregate of the net current assets and submitted banking references will be considered for working out the liquidity. The banking reference should be from a scheduled bank in India and it should not be more than 3 months old as on date of submission of bids.

(for calculation of liquidity, the audited balance sheet of current financial y ear 2024- 25 and audited balance sheet of previous year 2023-24 will only be considered and hence, the T2 liquidity may be uploaded accordingly.)

2.6.1.3. Other Criteria for Eligibility: The minimum eligibility of the bidder is calculated as per the technical criteria as per Annexure-I. The bidders obtaining requisite score (STB) shall only qualify the technical bid.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. - 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्तें</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
