1. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Generic

Manufacturer Authorization:Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

4. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

5. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

6. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.

7. Buyer Added Bid Specific ATC

- 1. Bidders are required to submit point wise confirmation to all the technical specificatio ns alongwith additional specification parameters. Non-submission of the same is liable for rejection of the offer.
- 2. Manufacturer's product catalogue or product images are to be submitted along with t he Technical bid/offer for the item quoted.
- 3. Bidders are advised to go through the '**Buyer Uploaded ATC document**" and sub mit all the documents (with Annexures) on firm's letterhead or stamped, signed by fir m's competent authority and upload in GeM alongwith the offer. Non-submission of th e same is liable for techno-commercial rejection of the offer.
- 4. All the **commercial terms and conditions** will be strictly as per GeM portal without any deviations. Bidders should submit bid only if Buyer added Bid specific Additional T erms & Conditions (ATC) read with GEM General Terms & Conditions (GTC) are accept able. Any other commercial term mentioned by the bidder as an attachment shall be i gnored

- 5. **Price Basis:** Prices on GeM portal are inclusive of all cost components i.e. GST, pack ing and forwarding charges, freight charges, transit insurance etc. Accordingly, the bi dders must quote price in GEM portal on F.O.R NALCO SMELTER STORE, ANGUL, ODIS HA basis/ free delivery at F.O.R NALCO SMELTER STORE, ANGUL, ODISHA basis inclusi ve of packing and forwarding charges, freight charges, GST, transit insurance etc. Any deviation to above conditions mentioned in the offer shall be ignored or the offer shall be rejected.
- 6. **Price Firmness:** All prices quoted must remain firm and fixed till complete executio n of the order (i.e without any escalation/price variation terms) .
- 7. **Payment Terms**: 100% payment shall be released within 10 days after receipt and acceptance of material at site and submission of Invoice followed by generation of CR AC, subject to reflection of the party's invoice/credit or debit note in GSTR 2A/ANX-2 (GST NEW RETURN) of NALCO.
- 8. Anti-profiteering clause (SEC171 OF CGST ACT): If any new tax/taxes is introduc ed on sale of goods/services, either in lieu of existing tax/taxes or as separate tax/tax es, then the overall incidence of tax/taxes on the vendor on account of its inputs and outputs wherever less than the incidence of existing taxes, then the vendor shall pass on to owner, the benefits thereof by way of commensurate reduction in the basic price w.r.t input tax benefits and reduction in tax chargeable to 'NALCO' w.r.t output tax be nefits in connection with goods and/or services provided.

If on the other hand, the incidence of tax/taxes is in excess of the incidence of existing tax/taxes, the owner on submission of satisfactory proof, shall reimburse the vendor the additional incidence of tax provided they are within the contractual compl etion date.

9. Income Tax / Billing clauses:

1. <u>Under Income Tax Clauses</u>

(A)For supply Contracts / Purchase Orders / Supply portion of LSTK

NALCO, being Buyer (under Section 194Q inserted in the Income Tax Act, 1961 vide Fi nance Act 2021) having total sales. gross receipts, or turnover from business above R upees Ten Crores during the last Financial Year, will deduct TDS under Section 194Q, w.e.f. 01.07.2021, at the prescribes rate of 0.1% on the purchase value of any goods, aggregate of which is exceeding the threshold limit of Rs.50 Lakhs in a Financial year.

Accordingly, Vendors/Sellers are not to collect tax at source under section 206C(1H) of the Act w.e.f. 01.07.2021, in case provisions of section are applicable to them.

The above is as per the current status and is subject to modification(s) based on amen dments/notifications under Income Tax Act, 1961, from time to time.

(B)For Other Contracts / Orders

Income Tax TDS, as applicable at the prevailing rate on the gross amount billed shall b e deducted from the contractor's bills.

2. <u>Under Income Tax / Billing Clauses</u>

Vendor / Party categorized/designated as "specified person" under Section 206AB of I ncome Tax Act, 1961 shall be liable for TDS at higher rate as provided under the said section, by NALCO. So, Vendors/Contractors are advised to submit self-certified copies of Income Tax return (ITR) for each of the Two Previous Years for which due date for fi ling of ITR has expired, along with the Invoice/Bill so as to facilitate NALCO, verify the applicability of Section 206AB.

- 10. **Delivery**: The items should be supplied within 45 days from the date of GeM Contrac t.
- 11. **Inspection :** Final inspection and acceptance shall be done at NALCO HOSPITAL and the result shall be final and shall be binding on the supplier on whom order is placed.
- 12. Bidders must ensure to indicate the name, mobile no., phone no., e-mail id of your co ntact person in the online offer for future correspondence.
- 13.
