1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

1. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

If for any reason whatsoever any TENDERER withdraws his tender at any time prior to expiry of the validity period or after issue of the Letter of Int ent, Purchase Order, fails or refuses to execute the order or to furnish the security deposit for faithful performance of the CONTRACT within the st ipulated time the amount of Earnest Money is liable to be forfeited.

Refund of Earnest Money:

* Performance Security [or Performance Bank Guarantee (PBG) or Security Deposit (SD)]:

The Performance Security for proper & timely fulfilment of the ORDER has to be submitted by successful BIDDER. No exemption will be made. Ven dor will have to submit Performance Security for **5% of basic contract value** within 14 days from date of placement of GEM Contract order, if n ot submitted in 21 days EMD shall be forfeited. No exemption will be mad e. This Performance Security should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier, including warranty obligations.

Performance Security may be furnished in the form of Insurance Surety B ond, account payee demand draft, fixed deposit receipt from a commerci al bank, bank guarantee issued/confirmed from RCF Approved bankers, o r online payment in an acceptable form, safeguarding the purchaser's int erest in all respects.

The Performance Security will be forfeited and credited to the procuring entity's account in the event of a breach of contract by the contractor. It shall be refunded to the contractor without interest, after he duly perfor ms and completes the contract in all respects but not later than 60(sixty) days of completion of all such obligations including the warranty under the contract.

A. <u>Experience Criteria</u>:

- I. The bidder shall be original equipment manufacturer (OEM) of "C onductivity Meter" and ISO certified.
- II. The bidder, must have designed, manufactured and supplied cond

uctivity meter to refineries / chemicals/fertilizers industries and the sam e shall be operating satisfactorily after installation continuously at least f or two years. As a documentary proof, the bidder shall submit self-attested photo copies of following documents:

- i. Copy of Purchase Orders with full technical details of conductivity meter
- ii. Certificate from user regarding satisfactory performance of conductivity meter after installation at least for two years is preferred.

B. Financial Criteria:

Average Annual financial turnover during the last three years, end ing 31st March of the previous financial year (2020-21, 2021-22, 2022-23 **OR** 2021-22, 2022-23, 2023-24) should be at least**Rs. 13. 70 Lakh**. The Turnover should be issued by practicing CA with Me mbership Number, seal and signed with UDIN.

In case the date of constitution / incorporation of the bidder is les s than 3 years old, the average turnover in respect of the complet ed financial years after the date of constitution shall be taken into account. In this case, the financial turnover during last financial ye ar / the average financial turnover during preceding two financial years should be at least **Rs. 13.70 Lakh**.

Make In India Declaration: As per revision dt 16.09.2021 of 'Public Procurement policy 2017', Non-local suppliers cannot partic ipate in tenders having estimates less than Rs. 200 crores. Offers of Class-I and Class-II Local suppliers as per Make in India policy can only be considered for evaluation and award of contract.
