1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

4. Generic

2. PDI: Pre-Dispatch inspection of all items shall be carried out by NTPC RIO at vendor's work as per NTPC approved SQP.

After receipt of Purchase Order, vendor shall raise inspection call online through URL <u>https://teamup.ntpcla</u> <u>kshya.co.in</u>. Help document for viewing approved documents & raising inspection call is provided in the gi ven URL.

After successful PDI, vendor has to submit Material Dispatch Clearance Certificate (MDCC) issued by NTPC RIO along with supply.

3. Bidders may please note that GeM is capturing and showing the IP addresses used by the Buyer and the Bidder(s) /Seller(s). The received bids having matching/common IP address with either Bidder (s)/ Seller(s) or Buyer, shall be outrightly rejected & shall not be considered for further evaluation.

4. Payment Term: As per GeM GTC

5. Guarantee/ Warranty certificate: 18 months from the date of dispatch or 12 months from the date of co mmissioning, whichever is earlier).

6. Bidders who will submit "UDYAM REGISTRATION CERTIFICATE", shall only be eligible for MSE benefits/ p urchase preference. Bidder(s) who will submit any other documents e.g. NSIC etc., will not be eligible for M SE purchase preference/ benefit.

7. MII document/ declaration shall be submitted along with the bid as per GeM Bid terms and conditions.

8. Nil Deviation:- "The sellers who participate in current Tender are deemed to have fully accepted all Ter ms & Conditions, Technical Specifications, Data Sheets, Drawings, Quality Plans, Buyer Added Bid Specific Terms and Conditions given in Bidding Documents, read in conjunction with Amendment(s)/ Clarification(s) / Addenda/ Errata (if any) issued by the Buyer prior to opening of Techno-Commercial Bids, and the same a re supposed to have been taken into consideration while making their Techno-Commercial Bid & Price Bid. Further it is construed that no deviation has been taken by the seller in this regard.

11. Post Bid Clarification:

16. Conflict of Interest

A bidder shall not have conflict of interest with other bidders. Such conflict of interest can lead to anti-com petitive practices to the detriment of Employer's interests. A bidder may be considered to have a conflict o f interest with one or more parties in this bidding process, if:

a. they directly or indirectly control, or are controlled by or are under common control of another entity; or

b. they have the same legal representative/agent for purposes of their bids; or

c. they have relationship with each other, directly or through common third party(ies), that puts them in a position to have access to information about or influence on the bid of another Bidder; or

d. Bidder and/or any of its allied entity(ies), which directly or indirectly control(s) or is(are) controlled by or is(are) under common control of another entity, has(ve) participated as a consultant in the preparation of t he design or technical specifications of the contract that is the subject of the tender; or

e. Bidder participates in more than one bid in this bidding process.

f. In cases of agents quoting on behalf of their principal manufacturers/service providers, one agent canno t represent two manufacturers/service providers or quote on their behalf in a particular tender enquiry. On e manufacturer/service provider can also authorize only one agent. There can be only one bid from the foll owing:

i. The principal manufacturer/service provider directly or through one Indian agent on his behalf; a nd

ii. Indian/foreign agent on behalf of only one principal.

For the purposes of this clause the term 'control' shall have the following meaning:
