- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. - 4. b) Fails to execute and perform the contract diligently or any of its obligations under the contract in accordance with the terms and conditions of the contract despite written notice to this effect

In above cases of defaults, SDBG of the party will be forfeited by NALCO.

# 16) PRE-BID/PRE-CONTRACT AGREEMENT (INTEGRITY PACT) & INDEPENDENT EXTERNAL MONITORS:

- (i) The average annual financial turnover of the bidder during the last 03 (three) years ending on the relevant date should be minimum 67 Lakhs (Rupees Sixty Seven Lakhs only) as per the annual report (audited balance sheet and profit & loss accounts) of the relevant period, duly authenticated by chartered accountant/ Cost accountant.

The exemption for submitting EMD may be considered only if photocopy of a valid Registration Certificate for the product is submitted along with the offer.

The original Bank Guarantee is required to be sent directly by the Bank under Speed Post or Re gistered Post to the addressee given in the tender document. The EMD shall be returned to all unsuccessful bidders after finalization of the order. The EMD of successful bidder will be returned after they accept the order, submit Security Deposit (SD) and b ank confirmation of the SD thereafter, as the case may be. If the successful bidder accepts the ord er but fails to submit the Security Deposit, the EMD will be retained. In such case the differential a mount towards SD and EMD will be deducted from the bills of vendor which may be released after receipt of SD. In the event of non-execution of order, the EMD shall stand forfeited.

19) **SPLITTING OF ORDER:** Present tender requirement is for 05 different items. NALCO may split its requirements and procure from techno-commercially accepted at least from Two Sources of Su pply in the ratio of 60:40. The L-1 bidder shall however eligible to get order for maximum upto 60 % of the total requirement.

The modality of splitting will be governed by following 02 possible outcomes:

CASE-I: In case, L-1 bidder is itself a MSE bidder, then they will get maximum 60% of the total req uirement, which includes 25% quantity reserved for MSE. Thus in this case further splitting based on MSE policy will not be considered. Remaining 40% of the total requirement shall be available to other bidders in the inter-se in order of their bid position and subject to matching of L-1 price orde r shall be placed on them.

CASE-II: In case, L-1 bidder is non-MSE bidder, then they will get maximum 60% of total requireme nt, but this will not include 25% of quantity reserved for MSE bidders.

For remaining 40% of the total requirement following modality to be followed:

20.2.1. Out of remaining 40% of the total requirement, 25% will be reserved for MSE (Micro and S mall Enterprises) bidders. Participating qualified MSEs, who have quoted within the price band of L -1+15% shall be given a chance to match with L-1 price in order of their bid position and take order for supply of upto 25% of the tender quantity. In case of participation of SC/ST category MSE

s in a tender, minimum 4% of tender quantity shall be reserved for placement of order on them, o ut of the 25% tender quantity reserved for MSEs as above, subject to matching with L-1 price in the tender. Further in case of participation of women owned MSEs, minimum 3% of tender quantity shall be reserved for placement of order on them, out of the 25% tender quantity reserved for MSEs, subject to matching with L-1 price in the tender.

20.2.2 Remaining 15% of the total requirement shall be available to all other bidders (other than L -1) participated in the tender. They shall be given a chance to match with L-1 price in order of their bid position and take order for remaining 15% of total requirement. However this category includes all the bidders including MSE bidders (other than L-1). That means if in case L-2 bidder is MSE bidder quoted within L-1+15% price band, they will be eligible to get 40% of the total requirement, subject to matching of L-1 price. Same analogy will be applicable for L-3, L-4, and L-5....H-1 bidder s.

However in case none of the bidder (other than L-1) agrees to match the L- 1 price, than 100% of t ender requirement will be awarded to L-1 bidder.

Part order: Bidder quoting in the tender invariably accepted the part order quantities.
