Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

Bidder Qualification Criteria for FRAMING OF SPECIFICATION FOR DESIGN , DEVELOPMENT , MANUFACTURING , TESTING AND SUPPLY OF PEDESTAL SYSTEM AS PER ANNEXURE - A

i) It is mandatory for the all bidder to sign a Non-Disclosure Agreement (NDA) with MTPF that any information relating to the MTPF specification in full or part thereof will not be shared with any third party without prior, formal approval from MTPF. (The format for NDA is attached as an Annexure B).

ii)The bidder must have capacity and capability to design, manufacture, integration and installation of pedestal system (consisting of consisting of various sub systems as a single unit as per technical specification).

iii)The bidder must have successfully supplied pedestal systems to the Indian Defence Forces/DPSU /DRDO either as a standalone system for the combat/ armoured vehicle application and has successfully integrated on a combat/ armoured vehicle with well established record. Bidder must submit relevant documents as a proof of supply of pedestal system to Indian defence forces/DPSU /DRDO.

iv).Considering the complexity of the system and being a design & development project, the bidder must be the Indian company for the pedestal system. The techno-commercial offer submitted through authorized dealer, authorized partner or authorized system house, or any other terminology used but carries the similar significance, shall be rejected without assigning any reason.

v) The bidder must possess a sound financial record. The company should be a profit-making company at least in three years out of the last five financial years. In this regard, the bidder must submit their financial statements in order to establish their claim. The min average turnover of the company in the last three financial years should not be less than Rs 2 Crore.

vi) All bidders must submit clause-wise offer with respect to all technical parameters (Attached at Annexure A)and other terms and conditions. . Notwithstanding anything mentioned in the technical offer, the statement and offer made in the "offer statement" with respect to technical & terms and conditions shall be firm and final.

vii) The technical offers would be evaluated as per the offer statement submitted by the bidder.
